Approving Form of Contract Documents for the BCPUD's Tank Site Pipeline Replacement Project, Awarding a Contract for the Project to the Lowest Responsible Qualified Bidder, Subject to Certain Conditions, and Finding that the Project is Categorically Exempt Under the California Environmental Quality Act ("CEQA"), Section 15301(b), Class 1 (repair and maintenance of an existing facility)

BE IT RESOLVED by the Board of Directors of the Bolinas Community Public Utility District ("BCPUD") as follows:

1. The Board of Directors hereby finds that the BCPUD's Tank Site Pipeline Replacement Project ("the Project") is Categorically Exempt from the provisions of the California Environmental Quality Act ("CEQA"), based on CEQA Guidelines, Section 15301(b), Class 1 (Existing Facilities). The Notice of Exemption to be filed for this Project is attached hereto as Exhibit A.
2. The BCPUD initiated a competitive bid process for proposals to install the Project and two (2) proposals were timely submitted by the due date of 2:00 p.m. on July 11, 2023. The BCPUD opened the two (2) sealed bids timely submitted on July 11, 2023. The BCPUD hereby finds that the lowest responsible qualified bid for the Project is the bid received from Piazza Construction.
3. The Contract Documents for the Project are attached to this resolution as Exhibit B and are hereby approved as to form.
4. The Board of Directors hereby awards a contract for installation of the Project in the form attached hereto as Exhibit B to Piazza Construction in the amount of \$318,850.00 (Three Hundred Eighteen Thousand Eight Hundred and Fifty Dollars), conditioned upon the BCPUD's timely receipt of all requisite bonds, certificates and agreements. The Board of Directors rejects all other proposals or bids submitted for the Project, and waives any irregularities in the proposal or bid of Piazza Construction.
5. The Board of Directors hereby authorizes the BCPUD President of the Board and/or the General Manager to:
 - (a) make minor technical amendments to the Contract Documents that do not affect the amount of the Contract;
 - (b) execute all Contract Documents;
 - (c) issue a Notice to Proceed; and
 - (d) to take all other actions necessary to implement the Project under the terms of the Contract Documents attached hereto as Exhibit B.


