**Description of Nature, Purpose and Beneficiaries of Project:**

The purpose of the project is to implement ADA and other physical improvements to 22 bus stops throughout Marin County in order to make them more “transit friendly” to riders while also addressing accessibility and pedestrian safety concerns. In addition, two new bus stops will be constructed within public right of way: a new paired stop at Redwood Blvd. and Hill Rd. in Novato; and a new stop at Francisco Blvd. East and Medway Rd. in San Rafael. Improvements include the following elements: accessibility improvements including path of travel improvements, widening passenger loading areas to meet ADA standards, installing benches and/or shelters, lighting improvements, bulb outs and striping for bus loading areas, and signage.
