Minutes

Convene Marin County Architectural Commission

- I. Call to Order and roll call --@ 10:11 A.M.
 - a) Public comment period --None
 - b) Additions to the agenda and approval of agenda –*Motion to approve agenda without modification by MZ, 2nd by CA. Approved by all present.*
 - c) Approval of minutes from 9/8/15 meeting –*Motion to approve minutes of 9/8/15 meeting by CA, 2nd by MZ. Approved by all present.*
- II. Resolve remaining clarifying questions posed by John Fordice during 4/24 meeting –JF restated question from 4/24/15 meeting regarding fee for application to the Commission for determination. Commissioners agreed there should be no fee for application to the Commission for determination imposed at this time.

JF restated question from 4/24/15 meeting regarding clarifying the involvement of the fire jurisdictions for building permits subject to Marin County Alternative Building Code provisions. Bill Kelley explained that the Marin County fire jurisdiction was a partner in developing the Marin County Alternative Building Code, and all such permit applications will involve fire jurisdiction review, with an emphasis on supporting alternative compliance.

JF restated question from 4/24/15 meeting regarding clarification of codes and standards requirements for building permits subject to Marin County Alternative Building Code provisions. Bill Kelley explained that prevailing California Building Standards Code provides the required basis and benchmark for building permits subject to Marin County Alternative Building Code. However, under statute and local ordinance, the threshold of "equivalent" performance is replaced with "satisfactory" performance in the consideration of alternative construction materials and methods of construction.
