On March 26, 2007, the Planning Commission held a continued public hearing and denied the Robertson Design Review and Lot Line Adjustment applications. On April 2, 2007, the Planning Commission will consider adoption of a resolution which reflects that decision. The application includes the proposed construction of three single-family homes and appurtenant improvements on a 12.3-acre property in Lagunitas. The property consists of three legal lots of record and the project includes the adjustment of the lot lines to accommodate more suitable building sites in response to environmental constraints at the site. The Robertson property is located at the terminus of the paved portion of Arroyo Road, approximately 0.6 miles north of Sir Francis Drake Boulevard, in the community of Lagunitas, Marin County, California. The subject property is located at 338, 350, and 360 Arroyo Road, Lagunitas, and is also identified as Assessor's Parcels 168-031-11, -12, and -13.
