**7:05.** Creekside Park Project. Craig Richardson, Marin County Open Space Planner, will update the board on work being done at the Hal Brown Creekside Park.

## 7:35 Schulter Design Review, 275 Vista Grande (Alton)

Request for Design Review approval to convert an existing 440 square foot garage into floor area and construct a new 508 square foot garage on a developed lot in Greenbrae. Various site improvements would also be entailed in the proposed development, including a rear deck and small additions to the front and rear of the house. The existing building area is 4,074 square feet and the existing floor area is 3,634 square feet. The proposed development would result in a building area of 4,984 square feet and a floor area of 4,467 square feet. Therefore, the project would result in a floor area ratio of 24 percent of the 18,732 square foot lot. The proposed building would reach a maximum height of 29.5 feet above surrounding grade and the exterior walls would have the following setbacks: 17 feet from the south front property line; 12 feet from the east side property line; 20 feet from the west side property line; more than 50 feet from the north rear property line.

Design Review approval is required because the project involves additional floor area that will result in a total floor area of more than 4,000 square feet. Story Poles are up.
