

- The County's new LCP went into effect August 2021, with the exception of the policies related to the Environmental Hazards
- CDA and California Coastal Commission staff have met to discuss a new approach to developing the Environmental Hazard Policies

#### ENVIRONMENTAL HAZARDS – INTERAGENCY SHARED PRINCIPLES

- **1**. Prioritize equity
- 2. Understand growing climate challenges and available adaptation and resilience options
- **3.** Ensure Coastal Act and the California Code of Regulations consistency
- **4.** Plan for future adaptation





#### ENVIRONMENTAL HAZARDS – INTERAGENCY SHARED PRINCIPLES

- 5. Consider a phased approach
- 6. Build upon existing Sea Level Rise (SLR) Guidance
- 7. Work to reconcile the tradeoffs inherent in coastal hazard planning

#### ENVIRONMENTAL HAZARDS – GUIDING FRAMEWORK

- Policies must be Coastal Act consistent
- Policies must be based on identified visions and objectives for each community/area
- Policies must set clear requirements and expectations
- Policies may be phased within the LCP to account for changes in physical circumstances and/or understandings over time





#### ENVIRONMENTAL HAZARDS – COASTAL ACT AND COMMUNITY CONSIDERATIONS

- Coastal Act requires protection for:
  - o natural landforms (bluffs, natural shorelines, etc.)
  - o cean and freshwater systems and habitats (creeks, wetlands, bays, etc.)
  - o public access (trails, overlooks, recreational areas, etc.)
  - o sandy beaches and sand supply
  - o public views
  - o popular visitor destinations (including coastal communities)
- Community considerations provide for
  - resilient communities that can adapt to SLR
  - o protection for both the natural and built environment
  - o greater certainty/clarity in permitting/development process





# ENVIRONMENTAL HAZARDS – vision/objectives/tradeoffs

- Develop visions and objectives for different areas, and then develop policies to achieve those
- Recognize coastal planning trade-offs, for example:
  - o armoring v. beaches
  - hardened edges v. natural conditions
  - o bluff/blufftop development v. natural landforms
- The challenge/opportunity how to achieve all of the above consistent with the law?





# ENVIRONMENTAL HAZARDS – **COASTAL PLANNING CONSIDERATIONS**



Shoreline armoring like this seawall leads to loss of sand generating materials and a loss of beach, effectively leading to ocean/bay waters covering such beaches at all times as sea levels rise. In contrast, where natural erosional processes are allowed to continue, beaches themselves can adapt and reform. This slide shows both circumstances
