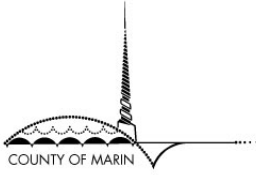

INSTRUCTIONS FOR PREPARING A
STATEMENT OF WITHDRAWAL OF A GENERAL PARTNER**

**This form should not be filed unless there is a
current fictitious business name statement on file in Marin County.**

The withdrawal of a general partner does not cause a fictitious business name to expire if the withdrawing partner files a statement of withdrawal in accordance with Business & Professions Code 17923 subdivisions (a), (b) and (c).

PLEASE PRINT OR TYPE. COMPLETE ALL APPLICABLE SPACES.

1. Enter the effective date of withdrawal.
2. Enter the file number, file date and county where filed, of the original fictitious business name statement.
3. NOTE: The Statement of Withdrawal of a General Partner must be published in the same manner as a Fictitious Business Name Statement, (within 45 days after filing, in a newspaper of general circulation in the county). [BP CODE 17922(a)] An affidavit showing publication will be filed with the County Clerk upon completion of the publication by the chosen newspaper. 4. Enter the exact spelling of the fictitious business name from which you are withdrawing with its street address.
5. Enter the name of the withdrawing partner and residence address.
6. Enter the place and date of execution of this statement.
