NOVATO UNIFIED SCHOOL DISTRICT SCHOOL BOND ELECTION MEASURE A

To repair and rehabilitate local schools, including health and safety repairs to classrooms, and qualify for State matching funds, shall Novato Unified School District, with annual audits and citizens' oversight, upgrade inadequate plumbing, electrical, heating and ventilation systems, renovate children's restrooms, repair deteriorating roofs, remove asbestos, repair dry rot, upgrade fire safety systems, improve intercom and public address systems, and make other improvements to school sites and buildings by issuing \$107 million of bonds within legal interest rates?

NOVATO UNIFIED SCHOOL DISTRICT FULL TEXT OF NOVATO SCHOOL IMPROVEMENT BOND OF 2001 MEASURE A

This Proposition may be known and referred to as the "Novato School Improvement Bond of 2001" or as "Measure A".

FINDINGS

The Novato public schools are a recognized leader in providing top quality education to Marin County students.

By providing outstanding service to generations of students in our community, the Novato public schools have made Novato an attractive home for new residents and businesses, and enhanced the quality of life as well as the property values of our community.

All of the school facilities of the Novato Unified School District are more than 30 years old, and the oldest school has been serving children and the community for more than 50 years.

In order to maintain our schools as effective places for teaching and learning for the future, and to be able to retain and attract students and quality staff to our programs, major renovations and repair work are needed to bring each of our elementary, middle, and high school campuses to current standards of safety, and to ensure they will remain standing for future generations.

The Board of Education of the Novato Unified School District has prepared a facilities plan and identified significant repair and rehabilitation needs that are more than the District is able to fund from currently available sources or annual revenues.

The Novato Unified School District has sought and continues to seek all available outside sources of funding for improving our school buildings, including local, state and federal grants and matching funds. The District has received State grant funds and has used these grants to complete critical projects, but outside money will not be sufficient to provide all of the District's facilities needs.

The voter-approved parcel tax ("A+ for Kids") can only be used for educational programs, and is not available for fixing school buildings.

It is necessary to seek voter approval of a bond measure in order to provide the local funding share of identified school facility repairs and modernization projects.

BOND AUTHORIZATION

By approval of this proposition by at least 55% of the registered voters voting on the proposition, the Novato Unified School District shall be authorized to issue and sell bonds of up to \$107 million in aggregate principal amount to provide financing for the specific school facilities projects listed in the Bond Project List attached hereto as Exhibit A, and in order to qualify to receive State matching grant funds, subject to all of the accountability requirements specified below.

BOND PROJECT LIST

The Bond Project List attached to this resolution as Exhibit A shall be considered a part of the ballot proposition, and shall be reproduced in any official document required to contain the full statement of the bond proposition.

The Bond Project List, which is an integral part of this proposition, lists the specific projects the Novato Unified School District proposes to finance with proceeds of the bonds. Listed repairs, rehabilitation projects and upgrades will be completed as needed at a particular school site. Each project is assumed to include its share of costs of the election and bond issuance, architectural, engineering, and similar planning costs, construction management, and a customary contingency for unforeseen design and construction costs. The final cost of each project will be determined as plans are finalized, construction bids are awarded, and projects are completed. Certain construction funds expected from non-bond sources, including State grant funds for eligible projects, have not yet been secured, and therefore the Board of Education cannot guarantee that the bonds will provide sufficient funds to allow completion of all listed projects.

ACCOUNTABILITY REQUIREMENTS

The provisions in this section are specifically included in this proposition in order that the voters and taxpayers of Novato may be assured that their money will be spent wisely to address specific facilities needs of the Novato Unified School District, all in compliance with the requirements of Article XIIIA, Section 1(b)(3) of the State Constitution, and the Strict Accountability in Local School Construction Bonds Act of 2000 (codified at Education Code Sections 15264 and following).

<u>Evaluation of Needs</u>. The Board of Education has prepared an updated facilities plan in order to evaluate and address all of the facilities needs of the Novato Unified School District at each campus and facility, and to determine which projects to finance from a local bond at this time. The Board hereby certifies that it has evaluated safety, class size reduction and information technology needs in developing the Bond Project List contained in Exhibit A.

Independent Citizens' Oversight Committee. The Board of Education shall establish an independent Citizens' Oversight Committee (pursuant to Education Code Section 15278 and following), to ensure bond proceeds are expended only for the school facilities projects listed in Exhibit A. The committee shall be established within 60 days of the date when the results of the election appear in the minutes of the Board.

<u>Performance Audits</u>. The Board of Education shall conduct an annual, independent performance audit to ensure that the bond proceeds have been expended only on the school facilities projects listed in Exhibit A.

<u>Financial Audits</u>. The Board of Education shall conduct an annual, independent financial audit of the bond proceeds until all of those proceeds have been spent for the school facilities projects listed in Exhibit A.

Special Bond Proceeds Account; Annual Report to Board. Upon approval of this proposition and the sale of any bonds approved, the Board of Education shall take actions necessary to establish an account in which proceeds of the sale of bonds will be deposited. As long as any proceeds of the bonds remain unexpended, the Superintendent of the District shall cause a report to be filed with the Board no later than January 1 of each year, commencing January 1, 2002, stating (1) the amount of bond proceeds received and expended in that year, and (2) the status of any project funded or to be funded from bond proceeds. The report may relate to the calendar year, fiscal year, or other appropriate annual period as the Superintendent shall determine, and may be incorporated into the annual budget, audit, or other appropriate routine report to the Board.

FURTHER SPECIFICATIONS

No Administrator Salaries. Proceeds from the sale of bonds authorized by this proposition shall be used only for the construction, reconstruction, rehabilitation, or replacement of school facilities, including the furnishing and equipping of school facilities.

or the acquisition or lease of real property for school facilities, and not for any other purpose, including teacher and administrator salaries and other school operating expenses.

<u>Single Purpose</u>. All of the purposes enumerated in this proposition shall be united and voted upon as one single proposition, pursuant to Education Code Section 15100, and all the enumerated purposes shall constitute the specific single purpose of the bonds, and proceeds of the bonds shall be spent only for such purpose, pursuant to Government Code Section 53410.

Other Terms of Bonds. When sold, the bonds shall bear interest at an annual rate not exceeding the statutory maximum, and that interest will be made payable at the time or times permitted by law. The bonds may be issued and sold in several series, and no bond shall be made to mature more than 25 years from the date borne by that bond.

CHARTER SCHOOL FACILITIES

 Consistent with the Novato Unified School District's obligation under Proposition 39 (approved by California voters in November 2000) and Section 47614 of the Education Code, provide classroom capacity, including furnishings and equipment, for approximately 200 in-district charter school students at a level comparable to students attending district-run schools, at a site or sites to be determined.

IMPARTIAL ANALYSIS BY COUNTY COUNSEL MEASURE A

If this Measure is approved by a fifty-five percent (55%) vote, pursuant to the Article XIIIA(1)(b)(3) of the California Constitution, the NOVATO UNIFIED SCHOOL DISTRICT will be authorized to incur bonded indebtedness of One Hundred Seven Million Dollars (\$107,000,000) with an interest rate not-to-exceed the limit set by law. The proceeds of the proposed bonds must be used for the purposes set forth in the Measure and for no other purposes, and will be subject to oversight by a citizens' oversight committee and annual independent audits to assure that the funds are spent only on school and classroom improvements.

REQUIRED STATEMENT REGARDING STATE MATCHING FUNDS MEASURE A

Approval of Measure A does not guarantee that the proposed project or projects in the Novato Unified School District that are the subject of bonds under Measure A will be funded beyond the local revenues generated by Measure A. The District's proposal for the project or projects assumes the receipt of matching state funds, which could be subject to appropriation by the Legislature or approval of a statewide bond measure.





TAX RATE STATEMENT **MEASURE A**

An election will be held in the Novato Unified School District (the "District") on November 6, 2001, to authorize the sale of up to \$107 million in bonds of the District to finance school facilities as described in the proposition. If the bonds are approved, the District expects to sell the bonds in series over time. Principal and interest on the bonds will be payable from the proceeds of tax levies made upon the taxable property in the District. The following information is provided in compliance with Sections 9400-9404 of the Elections Code of the State of California.

1. The best estimate of the tax which would be required to be levied to fund this bond issue during the first fiscal year after the sale of the first series of bonds, based on estimated assessed valuations available at the time of filing of this statement, is 5.996 cents per \$100 (\$59.96 per \$100,000) of assessed valuation in fiscal year 2002-03.

2. The best estimate of the tax rate which would be required to be levied to fund this bond issue during the first fiscal year after the sale of the last series of bonds, based on estimated assessed valuations available at the time of filing of this statement, is 5.995 cents per \$100 (\$59.95 per \$100,000) of assessed valuation in fiscal year 2008-09.

3. The best estimate of the highest tax rate which would be required to be levied to fund this bond issue, based on estimated assessed valuations available at the time of filing of this statement, is 6.0 cents per \$100 (\$60.00 per \$100,000) of assessed valuation in

fiscal year 2021-22.

Voters should note that estimated tax rate is based on the ASSESSED VALUE of taxable property on the County's official tax rolls, not on the property's market value. In addition, taxpayers eligible for a property tax exemption, such as the homeowner's exemption, will be taxed at a lower effective tax rate than described above. Certain taxpayers may also be eligible to postpone payment of taxes. Property owners should consult their own property tax bills and tax advisors to determine their property's assessed value and any

applicable tax exemptions.

Attention of all voters is directed to the fact that the foregoing information is based upon the District's projections and estimates only, which are not binding upon the District. The actual tax rates and the years in which they will apply may vary from those presently estimated, due to variations from these estimates in the timing of bond sales, the amount of bonds sold and market interest rates at the time of each sale, and actual assessed valuations over the term of repayment of the bonds. The dates of sale and the amount of bonds sold at any given time will be determined by the District based on need for construction funds and other factors. The actual interestrates at which the bonds will be sold will depend on the bond market at the time of each sale. Actual future assessed valuation will depend upon the amount and value of taxable property within the District as determined by the County Assessor in the annual assessment and the equalization process.



REBUTTAL TO ARGUMENT IN FAVOR OF MEASURE A

Our schools *have* become run-down and deserve to be fixed. That is not the reason many of us oppose Measure A. The reason is the **unfairness** of Measure A as a solution.

Measure A is unfair because even though most recent bond measures have passed in Marin County, this wasn't enough for some people. So, Proposition 39 was passed to lower the required percentage needed for approval. Although the proponents have given up trying to sneak bond measures through in special elections, they instead resorted to changing the rules to make it easier to pass them.

Also, Measure A would hit the elderly on fixed incomes hard. Unlike a parcel tax from which such residents can be exempted, a bond measure allows no such exemptions. After a lifetime of paying taxes, those who have chosen to retire in Novato on fixed incomes deserve a break, not Measure A.

Finally, Measure A places the greatest burden on those who already pay the most for education. Your choice of *when* you bought your home and *how much* you spent determines how much you pay. Thus, a retired person on a fixed income may pay several times as much of the cost of Measure A as a neighbor with three school age children living in an identical home.

Half of our state taxes, lottery revenues, parcel taxes, and billions in bond measures already go to education. Money is less the problem than how it is allocated and spent.

ARGUMENT AGAINST MEASURE A

This measure is a Proposition 39 Property Tax Increase. The Howard Jarvis Taxpayers Association opposes all Proposition 39 Property Tax Increases. For more than 100 years the California Constitution required a 2/3's vote of the people to increase your property taxes. That was changed to 55% for certain property tax increases with a \$30,000,000 highly deceptive campaign financed by billionaires whose companies pay little or no property taxes. The Howard Jarvis Taxpayer Association, by far the largest and most successful organization of ordinary taxpayers in California, fiercely opposed Proposition 39. Leading a campaign funded by average homeowners, we fought back. Out-spent 10-1, we lost in a very close vote. Your local School Board could have put a normal bond proposal on the ballot which would have required a 2/3's vote. Other school districts with elections on the same day chose a normal bond. The Howard Jarvis Taxpayers Association is not opposing any of them. But your School Board chose to try to impose a Proposition 39 Property Tax Increase upon you. If just 55% vote "Yes" it will result in about \$214,000,000 in new property taxes in your school district, including interest, fees and charges. The Howard Jarvis Taxpayers Association strongly recommends that you vote "No" on this property tax increase.

REBUTTAL TO ARGUMENT AGAINST MEASURE A

A significant benefit of a Proposition 39 bond measure is the increased requirements it imposes for accountability to Novato's taxpayers. Proposition 39 requires that independent audits be conducted and a citizens' oversight committee be established to ensure that bond proceeds are used only for projects outlined in the ballot and approved by voters.

Your tax dollars will go directly to fixing the most critical needs at each of our public school facilities.

- Measure A funds will be used only to improve our current facilities - no new construction is included.
- Measure A does not include the District Education Center or the Maintenance facility.
- Measure A funds cannot be used for administrative salaries.

All of Novato's schools are 30 years old or more - the oldest are 50. The District performs regular maintenance and repairs and has been aggressive in pursuit of additional state and federal funding for modernization and critical hardship. But the reality is these buildings are at an age where extensive work is required to keep them safe. Passage of Measure A will provide \$107 million to bring our school facilities to current standards of safety and to accommodate the demands of today's instructional programs.

Modernized schools mean an increase in property values for everyone. As taxpayers, businessowners and members of the Novato community we stand ready to vote YES on Measure A - YES to protecting our community's investment in our school facilities and YES to providing safe and effective places for teaching and learning.

Unsafe is unacceptable. Vote YES on Measure A.
