NOTICE

If you forgot to sign your ballot return envelope, the Elections Department will send a letter with a postage-paid envelope so you may correct the problem. Or you may print and complete this form and return it as indicated in the instructions below. Please note that the signature provided on the completed Statement may be added to your registration record to be used for signature comparison purposes in future elections.

UNSIGNED BALLOT STATEMENT

I, _____, am a registered voter of Marin County, State of California. I declare under penalty of perjury that I requested (or I received) and returned a ballot and that I have not and will not vote more than one ballot in this election. I am a resident of the precinct in which I have voted, and I am the person whose name appears on the ballot envelope. I understand that if I commit or attempt any fraud in connection with voting, or if I aid or abet fraud or attempt to aid or abet fraud in connection with voting, I may be convicted of a felony punishable by imprisonment for 16 months or two or three years.

I understand that my failure to sign this statement means that my ballot will be invalidated.

RETURN INSTRUCTIONS ON PAGE 2

READ THESE INSTRUCTIONS CAREFULLY.
FAILURE TO FOLLOW THESE INSTRUCTIONS MAY CAUSE YOUR BALLOT NOT TO COUNT.

1. To ensure that your ballot will be counted, your statement should be completed and returned as soon as possible, but no later than 5 p.m. two days prior to the certification of the election.
2. You must sign your name on the line on page 1 (Voter's Signature).
3. Place the statement into your own mailing envelope addressed to the Marin County Elections Department. Mail, deliver, or have delivered the completed statement to the elections official. Be sure there is sufficient postage and that the address of the Marin County Elections Department is correct.
4. If you do not wish to send the statement by mail or have it delivered, you may submit your completed statement by fax or email to the Marin County Elections Department, or submit your completed statement to a vote center within Marin County or a ballot drop-off box before 8 p.m. on Election Day.

Deadline to sign your envelope or return this statement is
5 p.m. two (2) days before the election is certified.
