### SIGNATURE VERIFICATION STATEMENT

I am a resident of the precinct in which I have voted, and I am the person whose name appears on the ballot envelope. I understand that if I commit or attempt any fraud in connection with voting, or if I aid or abet fraud or attempt to aid or abet fraud in connection with voting, I may be convicted of a felony punishable by imprisonment for 16 months or two or three years.

***I understand that my failure to sign this statement means that my ballot will be invalidated.***

READ THESE INSTRUCTIONS CAREFULLY.

FAILURE TO FOLLOW THESE INSTRUCTIONS MAY CAUSE YOUR BALLOT NOT TO COUNT.

1. We have determined that the signature you provided on your ballot does not compare with the signature(s) on file in your voter record. To ensure that your ballot will be counted, the signature verification statement must be completed and returned as soon as possible.
2. The signature verification statement must be received by the Marin County Elections Department no later than 5 p.m. two days prior to certification of the election.
3. You must sign your name where specified on the signature verification statement (Voter's Signature).
4. Place the signature verification statement into the postage-paid return envelope. Mail, deliver, or have the completed statement delivered to the Marin County Elections Department.
5. If you do not wish to send the signature verification statement by mail or have it delivered, you may submit your completed statement by email or fax to the Marin County Elections Department, or submit your completed statement to a vote center within Marin County or a ballot drop-off box before 8 p.m. Election Day.

Deadline to sign your envelope or return this statement is  
**5 p.m. two (2) days before the election is certified.**
