Description of Nature, Purpose, and Beneficiaries of Project:

The work to be done, in general, consists of roadway repairs, including: cold planning of asphalt roadway; placement of Hot Mix Asphalt (HMA) materials; removal and replacement of concrete curb, gutter, sidewalk, curb ramps, and valley gutters; pruning and removal of tree roots; lowering and adjusting utility covers to finish grade; removal and replacement of traffic striping and pavement markings; shoulder backing installation and loop detector replacement.
