Description of Nature, Purpose and Beneficiaries of Project:

The project would consist of four solar canopies over areas of the existing school parking lot adjacent to Sir Francis Drake Blvd. These would have the following dimensions:

- One approximately 30 x 151-foot canopy with 160 modules (panels), minimum height of 12 feet.
• One approximately 37 x 120-foot canopy with 160 modules (panels), minimum height of 12 feet
