Description of Nature, Purpose, and Beneficiaries of the Project: The proposed project consists of granting a special use permit to the San Geronimo Valley Community Center for the 3rd Annual Valley Car Show at San Geronimo Park's Parking Area and approximately 100 parking spaces. The event would occur on July 19, 2025 between 11AM and 3PM. Set-up and take down would occur on the evening of July 18th and the morning of July 20th. Approximately 300-500 participants are anticipated. The event would include amplified sound and the sale of food, drink, or merchandise.

Public Agency Approving Project: Marin County Parks

Name of Person or Agency Carrying Out the Project: Chris Chamberlain, Director and General Manager

Reasons for Exemption: Marin County Parks has reviewed the special event permit application in the context of San Geronimo Park and has determined that authorizing the permit the event is categorically exempt from the California Environmental Quality Act under the following sections of the California Administrative Code:

Section 15323: Normal Operations of Facilities for Public Gatherings. The proposed project consists issuing a special event permit at an existing facility for a public gathering. San Geronimo Park was designed with reservable space for this type of event and there is a past history of this facility being used for this purpose. There is a reasonable expectation that this event would not represent a change in the operation of the facility and that the event would not result in cumulative impacts; significant impacts on the environment due to unusual circumstances; affect the significance of historical resources. The project is not located within an officially designated scenic highway or on a hazardous waste site pursuant to Government Code Section 65962.5.






NOTICE OF EXEMPTION – LOCATION MAP SAN GERONIMO PARK – 3rd Annual Valley Car Show May 7th, 2025
