Government Code § 53051 requires a public agency¹ to file a Statement of Facts within 70 days after the commencement of its legal existence. When there is a change in information, the agency is required to file an amended Statement within 10 days. It is the duty of the Secretary of State and the County Clerk of each county to establish and maintain an indexed "Roster of Public Agencies."
