



Looking Ahead in 2010

On January 4th, I was elected President of the Board of Supervisors for this year. I'm sure it comes as no surprise that 2010 will be a challenging year, due to the budget shortfall counties and cities in California are experiencing. Marin is fortunate that we have acted prudently these past years, and are not in the dire circumstances some counties find themselves in. We have the highest bond rating of any county in California.

We have taken many actions in recent years to address the budget challenges including:

- Adopting a lower-cost retiree health plan in 2007 for new employees, and beginning to set aside funds for the unfunded liability of retiree healthcare
- Enacting pension reforms such as basing pension benefits on a three year average rather than the highest single year and capping annual cost of living adjustments at two percent
- Developing and implementing a five-year \$20 million road maintenance project
- Reducing spending by \$27 million over the past two years and eliminating over 100 vacant positions

District 5 Update on Marin Clean Energy

If you live in unincorporated Novato (Black Point, Green Point, Indian Valley, Loma Verde and Bel Marin Keys) you are in the service territory of the newly launched Marin Clean Energy.

MCE is a "Community Choice Aggregation" (CCA) program under the Marin Energy Authority (MEA): a joint powers authority (JPA) made up of the County and several Marin cities and towns.

MCE is now launching Phase 1 of its service. **Most residential customers in unincorporated Novato are not participants in Phase 1**, which represents about 20% of the MEA energy load and is made up mainly of municipal and business ratepayers. 491 residences in unincorporated Novato, a relatively small number of residential ratepayers in this area, have been enrolled in Phase 1 and should have received a first notice by this time.

The state legislation which created the CCA structure (AB117) requires ratepayers within the service territory to opt out if they do not wish to participate in the CCA, and requires the CCA to send four opt out notices over a 120-day opt out period. **The current opt out period applies to Phase 1 only.**

If you are in Phase 1, you should have already received one or more opt-out notices that will be mailed to you approximately every 30 days during the opt out period (the first of these was mailed in early February). In addition to the progress made due to these efforts, the County is taking action to address a \$15 million shortfall for 2010-11, which is a structural budget deficit that would go to \$50 million by 2014-15 if not addressed.

I am on the Board's Long Term Budget Restructuring Committee which involves employee and community outreach, such as the first community meeting held in Novato which provided valuable input.

I also know that it is imperative that we come up with new ways of doing business as a County that will reduce services while continuing to strive toward providing excellent services where possible. My goal is to ensure that we do the most important things well.

I am confident that we will get through this difficult time together, and I ask you to please keep in touch with me with any suggestions or concerns you have. I always remind myself of Mother Teresa's admonition: "Life is a challenge. Meet it!"

Thank you for your support and hard work as we go forward together.

2009 in Review

Together, we accomplished a lot in 2009. Here are some of the highlights:

- Launched the Marin Economic Forum (MEF) a public-private partnership to focus on the link between a sustainable local economy as the key to achieving our environmental and social equity goals
The MEF will work to strengthen Marin's target industries, will collect, analyze and disseminate data and reports on various aspects of our local economy, will work to illustrate the benefits of local economic health as an integrated element of overall civic goals, and will seek out opportunities to aggregate resources for local businesses
- After a very successful launch in 2008, we are launching the second round of distribution for the Vial of L.I.F.E. Program to help our emergency responders save lives (see the Marin County Fire Department website at www.xmrfire.org/mrn/community/vial_of_life.aspx)
- Adopted a revised Integrated Pest Management (IPM) ordinance that establishes improved and greater accountability, infrastructure, and public transparency
- Formed a partnership with the County of Marin, City of Novato, North Marin Water District, and Novato Sanitary District to develop a Novato Watershed Program to address flooding, water quality, water conservation and habitat restoration throughout the 44-square-mile Novato watershed
- Implemented a new service called Novato Dial-A-Ride, a bus service that provides passengers curb-to-curb pick-up and drop-off service and is available to all residents in the Novato service area. For hours of operation and more information visit the Marin Transit website at www.marintransit.org
- Initiated a long-term budget restructuring process and brought the public input process to you by hosting the first County budget community forum in Novato
- Certified nine Green Businesses in Novato

The City of Novato is not a member of the MEA. If you live within Novato city limits, you are not in the Marin Clean Energy Service Territory, and will continue to receive your electricity from PG&E.

Being in the MCE program means that you have three choices:

- **You may “opt out”**, and continue to receive electricity from PG&E’s portfolio. To opt out, call (866) 743-0335, or visit www.pge.com/cca.

You may opt out at any time, but if you do so after the 120-day opt out period, additional fees, terms and conditions may apply.

- **You may remain in MCE.** To remain in MCE at the default “light green” portfolio option, which will include 25% certified renewable energy, you do not need to take any action.

If you decide to remain in MCE Phase 1, your MCE service is expected to commence in early May, 2010. Rates have been set to be the same as PG&E current rates. You will have an additional 60 days beyond commencement of service to opt out without a fee or penalty should you choose to do so.

- **If you are in the MCE service territory, whether or not you are in Phase 1 you may “opt up”**, by making a request to enroll in MCE’s “deep green” portfolio option, which offers a voluntary 100% renewable energy service option. Again, this option is available to all ratepayers within the MCE service territory, even if they have not been identified for Phase 1 participation.

In any of these cases, only the electricity generation portion of your bill will be affected. Your electric utility bills will continue to be sent by PG&E, which will continue to collect its standard fees for distribution and transmission of power through its electricity infrastructure. MCE and PG&E have signed an agreement to this effect as required by AB117.

MEA has indicated that the timing of its Phase 2 (and opt-out notices to ratepayers eligible for the MCE program during Phase 2) is approximately 18 months after Phase 1 commences.

2010 Census Information

What is the Census? The U.S. Census counts every resident, citizens and noncitizens alike, in the United States and is required by the Constitution to take place every 10 years. In March of 2010, census forms will be delivered to every residence in the United States.

The Census is a short 10-question form to account for everyone living at your residence as of April 1, 2010. These 10 questions ask: name, sex, age, date of birth, Hispanic origin, race, household relationship, and if you own or rent. The Census DOES NOT ask about the legal status of respondents or for their Social Security numbers. You should be counted where you live and sleep most of the time. For people who may not have a permanent address or a home, service based organizations, such as homeless shelters and soup kitchens, will have census forms where you can be counted.

While most residents in Marin will receive English-only materials, households in areas with high concentration of Spanish-speaking residents may receive bilingual forms. Forms are

available in six languages: English, Spanish, Chinese (simplified), Korean, Russian and Vietnamese. You will be able to request a form in one of the five non-English languages via toll-free numbers that will be available closer to Census Day.

If you don't mail the form back, you may receive a visit from a census taker, who will ask you the questions on the form. If you did not receive a form, call the Telephone Questionnaire Assistance center at 1-866-872-6868. (If you prefer a Spanish-speaking operator, dial 1-866-928-2010.) The lines will be open from 8 a.m. to 9 p.m. seven days a week from February 25, 2010 through July 30, 2010. For the hearing-impaired, TDD 1-866-783-2010. As always, any and all personal data you provide is confidential and protected by federal law.

2010 Census Key Dates

February - March 2010—Census questionnaires are mailed or delivered to households

March - April 2010—Census questionnaires available at select public sites for individuals who did not receive one by mail

April 1, 2010—Census Day

May - July 2010—Census takers visit households that did not return a questionnaire by mail

Dec. 31, 2010—By law, the Census Bureau delivers population counts to the President

March 2011—By law, the Census Bureau completes delivery of redistricting data to states.

A Complete Count: The Importance of Census Data

- Every year, the federal government allocates more than \$400 billion to states and communities based, in part, on census data.
- Census data are used to determine locations for retail stores, schools, hospitals, new housing developments and other community facilities.
- Census data determine boundaries for state and local legislative and congressional districts.
