

**COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM (CDBG) AND HOME PROGRAM
SCHEDULE OF PUBLIC HEARINGS

Federal funding for the CDBG and HOME Programs will be voted on for the 2018-19 Fiscal Year at a series of local and countywide meetings. All interested parties are encouraged to attend these preliminary planning area meetings to discuss funding allocations for 2018-19 Fiscal Year applicants. Funding recommendations will be made for each applicant in their respective planning area and will be adopted at the April 5th Countywide Priority Setting Committee meeting and May 8th Board of Supervisors meeting. The cities of Novato and San Rafael adopt their own funding for their respective planning areas at local City Council meetings listed below.
