The meeting will be a workshop format. No decisions will be made and no votes will be taken. Topics may include a general discussion of funding priorities, an opportunity for committee members to present comments and questions about applications for staff to consider, and a chance to hear from staff about the applications received prior to funding recommendations.

Applicants should note that the Committee will make its recommendations for funding allocations at a separate series of public hearings scheduled for March and April 2018. The meeting will be open to the public, and the agenda includes open time for public comment.

This meeting is being held in response to a request from several community members of the Priority Setting Committee who suggested that the Committee meet with staff after applications for 2019-20 funding have been received, but before staff recommendations are issued.
