Local, State, and Federal Housing Funds to be Discussed and Allocated

NOTICE IS HEREBY GIVEN that there are five (5) upcoming meetings regarding multiple local, state, and federal funding sources for housing projects. These funding sources are the State Permanent Local Housing Allocation (PLHA) matched by Local Marin County Affordable Housing Fund (HTF), Federal HOME-ARP (new funds allocated through the American Rescue Plan), Federal Community Development Block Grant (CDBG), and HOME Investment Partnerships Program (HOME).

Funding applications will be discussed and voted on for the 2023-24 fiscal year at the upcoming Countywide Priority Setting Committee meetings, Novato City Council meeting, and San Rafael City Council meeting. Recommendations from these meetings will then be sent to the Marin County Board of Supervisors for final approval. Meeting dates are listed below.
