#### Marin County Draft Housing Element 2015-2023

- WHO:** Any and all interested persons.
- WHAT:** The Marin County Planning Commission has scheduled three public hearings on **July 28, August 25 and November 17, 2014**, at which time the Planning Commission will review the Draft Housing Element for 2015-2023 and make a recommendation to the Board of Supervisors (BOS). The BOS will then review and consider adopting the Draft at one or more separate hearings expected to be scheduled in late fall 2014.
