RECOMMENDATIONS:

- 1. Review the administrative record and conduct a public hearing
- 2. Continue the public hearing to Tuesday, March 30, 2004, at 5:00 p.m.

DISCUSSION

This meeting is the first public hearing on the draft Marin Countywide Plan update. Today's hearing will begin with the introductory section of the Plan. Subsequent meetings will continue to progress through the document sequentially with three hearings tentatively scheduled each for the Natural Systems and Built Environment elements and one meeting for the Socioeconomic element. The tentative hearing schedule is an estimation of time and more time may be required to complete individual sections and/or review of the entire document. However, staff will be requesting Commission direction on individual sections of the Plan at each hearing in order to return with revisions at a later date.

Following today's public hearing, it will be necessary to continue the public hearing to a specific date and time. In order to keep to the tentative schedule to the extent possible, staff is recommending that each section of each element be reviewed as follows:

- 1. Staff Presentation
- 2. Commission Questions
- 3. Public Comment (typically three minutes per speaker)
- 4. Commission Comment and tentative direction.
