#### 1. Minutes.

The minutes were accepted from May 22, 2014.

## 2. Discuss Feedback from Community Workshop on June 5, 2014.

Staff discussed a summary of the ideas and input received from June 5 workshop and survey of issues. With regards to the topic of Community Character and Home Size, while there was no clear consensus on the feedback received from the workshop on whether standards to regulate home size are needed in the community plan, the proposed draft will discuss the recommendation developed by the Advisory Committee, in addition to two other options.

Staff will follow up with Novato Fire and Marin County Parks staff to discuss the feedback regarding the topics of environmental hazards and parks, recreation, and open space, respectively.

With regards to the Village Center land use, the committee confirmed the community plan should encourage resident serving commercial uses.

# 3. Discuss Outline of Content for the Community Plan.

Staff discussed a detailed outline of the proposed contents for the community plan. With regards to the Natural Resources section, the committee suggested including a program to

study the potential expansion of the Baylands Corridor in the area, and to clarify what is meant by "wildlife friendly" fencing. In addition, add a policy to encourage the natural eradication efforts of rodents through owls. Staff will follow up with Novato Fire to confirm where there are adequate locations to turn around for fire apparatus in the Gridiron area. It should be noted that the Light Pollution strategies apply to both commercial as well as residential development in the planning area, and that one of the major implications from Sea Level Rise would be the impacts on access both into and out of the community, including Highways 37 and 101.

The committee agreed not to show a map of Sudden Oak Death since the map is not accurate. It was suggested language was needed to clarify what species of trees are impacted from Sudden Oak Death, and if UCD recommends removal of bay trees.

In the Transportation section discuss that fences and other structures are not allowed to be located within the road right of way and may impede access. In addition, include a discussion on access to the SMART station and transit service. Confirm if there is transit service along Highway 37.

In the section on Community Character and Land Use, the committee suggested that it recognize the older cottages and mansions and encourage their preservation. Examples include the former "I. Magnani" house, the Antonia house, and the former school house on School Road.

In the Trails background section, discuss physical constraints that may limit the development of new trails, such as narrow and steep roadways and ADA requirements. Also distinguish between informal trails and sanctioned ones, and that money is needed to maintain trails once they are developed.

In the Public Facilities and Services section, describe who LAFCO is and what they do.
