INTERAGENCY REFERRAL OF PLANNING APPLICATION Brownridge Design Review and Tree Removal Permit Project ID P2780

June 16, 2020

The Marin County Planning Division is requesting that public agencies with regulatory authority over the Brownridge Design Review and Tree Removal Permit provide us with written comments on the project by June 30, 2020. The property is located at 115 Woodland Road, Kentfield, further identified as Assessor's Parcel 075-051-02. The applicant's name and contact information is provided below.

The applicant requests to tear down an existing residence on a developed lot, rendering the lot vacant, and requests Design Review approval to construct a new 4,694 square foot residence with a 540 square foot attached garage and the remodel an existing guest house. Various site improvements would also be entailed in the proposed development, including installation of a new pool, and landscaping. The proposed development would consist of 6,465 square-feet of total building area and 5,925 square-feet of total floor area, which would result in a floor area ratio of 13 percent on the 43,560 square-foot lot. The residence would reach a maximum height of 26 feet 10 inches above existing grade. The residence would have the following setbacks from the exterior walls: 30 feet from the northwestern front property line; 15 feet from the northeastern side property line; 15 feet from the southwestern side property line; more than 100 feet from the southeastern rear property line.

Design Review approval is required because the project is located in a planned zoning district. A Tree Removal Permit is required because more than one "protected" tree is proposed to be removed.
