7:35. Discussion: Culvert Replacement along Multi-Use Path near Creekside

The culvert near Creekside Park, upstream of the Bon Bridge along the multi-use path that runs from Bon Air Road to College Avenue, is being replaced by the County Parks Department. The new culvert will allow more tidal flow into the marsh and improve habitat for marsh species. County Parks proposes use of some CSA 17 funds to help pay for the replacement project. Descriptive material was emailed earlier.

## 7:55 Marcus Variance, 10 Wolfe Glen Way (Scoble)

Variance sought from the 25-foot front yard setback to allow conversion of an existing garage into habitable floor area, and construction of a new two-car garage in the setback area. The existing residence has 2,982 square feet of building area and 2,494 square feet of floor area which, with the variance, would become 3,249 square feet of building area and 2,822 square feet of floor area. This would result in a floor area ratio (FAR) of 25 percent on the 11,188 square foot lot. The new garage would be up to 14.75 feet above existing grade with the following setbacks: 18 feet from the front line, 32.5 feet from the south side line, more than 100 feet from the western rear line.
