7:35 McCall Design Review, 237 Hillside Avenue (H. Scoble)

Revised information including slight modifications to proposal for a new 4,724 s.f. house, including attached 552 s.f. garage, on a 23,122 s.f. vacant lot with a slope of 53%. Project setbacks: 3 feet from west front, 6.22 feet from north side, 17.39 feet from south side, 119.75 feet from east rear.

8:10. Goldman Design Review, 199 Hillside Avenue (J. Drake)

Proposed construction of a 4.213 s.f. residence and detached parking deck on a vacant lot. The project includes 3,673 s.f. of total floor area, would have an 11% floor area ratio on the 32,077 s.f. lot, and reach a maximum height of 30 feet. Setbacks: 37 feet from south front, 64 feet from east side, 37 feet from west side, and 44 feet from north rear. Project also includes landscaping, retaining walls up to 8 feet high, new stairs, and a new deck on the rear portion of the residence. Fourteen trees, including 9 classified as protected, would be removed.

8:30 Friedman Design Review, 201 Laurel Grove Avenue (S. Greeley)

Revised submittal to address incompleteness items identified in the July 2014 application. The project would convert an existing garage to living space, adding 420 s.f. of floor area to the home's first floor, resulting in a 5,332 s.f. structure on the 35,745 s.f. lot with a floor area ratio of 17.9% and maximum height of about 28 feet. Project also includes an 111 s.f. net addition to the lower floor of the existing pool house.
