7:35. College of Marin creek wall fence proposal and other campus updates

COM Vice President of Finance and College Operations Greg Nelson will update board members on fencing related to the creek wall and other campus activities including a tree study and the role the college is playing with recycling of trees into other materials. The fence is the chain link fence the runs from College Avenue along the creek into the campus, and which is currently intertwined with various foliage.

7:55. Tribolet Design Review, 3 Meadow Avenue (J. Drake)

Application for remodel and reconfiguration of an existing residence, including construction of two additions; one on the rear portion of the first story, and one on the front portion of the front of the residence, above the garage. An existing non-conforming structure located in the side yard would be removed. The existing two-story structure is 26 feet high, with 3,507 square feet of floor area on a 13,609 square foot lot. The proposal would add approximately 575 square feet for a total of 4,082 square feet of floor area (30% Floor Area Ratio) and 4,622 square-feet of total building area, with a 30 foot height from existing grade. Minimum approximate setbacks of the additions from property lines would be: 25 feet from the east front, 30 feet to the west rear, 10 feet from the north side, and 25 feet, 8 inches from the south side. Additional project components that do not require Design Review include a new pool, spa and outdoor dining structure in the rear yard, and new landscaping and hardscape.
