# 7:30 Open Time and Review of Minutes of April 22, 2015

## 7:35. Discussion: Hendrickson Tree Removal, 141 Laurel Grove Avenue (Taylor)

Application for permit to remove one heritage tree from the rear yard at 141 Laurel Grove Avenue. The tree is an 18" diameter oak which qualifies as a heritage tree under the Tree Protection Ordinance. Two trees that proposed to be removed are 12" and 10" oak trees, also located in the rear yard, and which are considered protected under the Tree Preservation Ordinance. Per the Tree Preservation Ordinance, a Tree Removal Permit is required for the removal of more than two protected trees; therefore the two protected trees are exempt from the Tree Removal Permit. Tree Removal Permit approval is required because the removal of a Heritage Tree (an Oak at 18" Diameter at Breast Height in size) requires review and approval per Chapter 22.62 of the Marin County Code.
