7:05. Robino Land Division, 127 Hill Drive, Kentfield. (Drake)

Application to divide a developed 83,900 square foot lot into two lots. Lot 1, with an average lot slope of 29.3%, is proposed to consist of 40,340 square feet. The existing residence would be retained on Lot 1. Lot 2, with an average lot slope of 47%, is proposed to consist of 43,560 square feet. The proposed setbacks, from the existing residence to the proposed lot lines, are as follows: approximately 160 feet from the (northern) front property line; approximately 44 feet from the (southern) rear property line; approximately 65 feet from the (eastern) side yard property line; and approximately 25 feet from the proposed (western) side yard property line.

A conceptual building envelope, sized to accommodate a new residence approximately 5,000 square feet in size, is included on Lot 2. Access to the proposed residence on Lot 2 is proposed to be created via a new driveway connected to Madrone Avenue. The proposed setbacks, from the proposed building envelope to the proposed lot lines (taking into account that the 'front' property line borders Madrone Avenue in this case), are as follows: approximately 25 feet from the (western) front property line; approximately 25 feet from the (eastern) rear property line; approximately 15 feet from the (northern) side yard property line; and approximately 15 feet from the proposed (southern) side yard property line. An existing shed located on the proposed new lot is would be demolished.
