Project consists of 4,835 sf. total building area and 3,751 s.f. total floor area resulting in a floor area ratio of 12 percent on the 32,077 s.f. lot. The residence would include 1,649 s.f. on the lower level, 1,588 s.f. on the main level, 378 s.f. on an office level plus the garage. Setbacks for the project range from 28 to 74 feet from property lines. Thirteen trees would be removed, eight of which are classified as protected trees. **This meeting will focus on identifying completeness issues.**
