County personnel working on a study of potential impacts of sea level rise in Marin County will make a presentation to the board. The County is teaming with local town and city governments and service districts for this project, for which an initial report is due late this summer. The work is part of the County's Bay Water Adaptation Vulnerability Evaluation (BayWAVE) program and is funded through the Coastal Conservancy and Marin County. Initial analysis indicates that multiple areas of Kentfield could be impacted by ocean flooding under the scenarios used for the study (10 inches, 20 inches, 60 inches, and each also in conjunction with a 100-year storm) This presentation should take about an hour. And includes the potential threat, possible outcomes in a no action scenario, and adaptation opportunities to reduce risk.
