7:05. Kosmowski Design Review and Variance, 15 Poplar Drive (Cardoza)

Request for Variance and Design Review approval to construct 991 square feet of new additions onto an existing 4,482 square-foot single-family residence and a new 775 square-foot detached accessory structure (garage) on a developed lot. The 1,766 square feet of proposed new development would result in a floor area of 6,419 square feet and a floor area ratio of 10.68% on the 60,131 square-foot lot. Proposed additions would reach a maximum height of approximately 16'10" above surrounding grade and have the following property line setbacks: 40 feet from the northern front line; 0.5 inches from the western side; 68 feet from the eastern side; 84' 8.5" from the southern rear property line. The proposed detached garage would reach a maximum height of 12'8" above grade and have the following setbacks: 14'3" from the northern front line; 46' 6.5" from the southern rear property line.
