7:05. Matthiesen Design Review, 5 Pine Court, Kentfield (Cardoza))

Request for approval to construct 1,207 sf of additions onto the existing residence.. The 1,207 sf addition would result in a floor area of 3,692.7 sf and a floor area ratio of 23 % on the 15,834 sf lot. The proposed building would reach a maximum height of 25 feet, one inch above surrounding grade and exterior walls would have the following setbacks: 29 feet, seven inches from the southern front property line; 10 feet from the western side property line; 23 feet, nine inches feet from the eastern side property line; 25 feet, 3 ½ inches from the northern rear property line. Other site additions would include a new driveway and new trash enclosure in the front of the property and a new pool in the rear of the property. 7:30 Chang Family Design Review, 5000 Lo Cerros Drive, Greenbrae (Kilgariff) Requests for approval to construct a 402 sf accessory structure, to be used as a garage. The 402 sf of proposed development would result in a change to the existing floor area ratio of 25% on the 11,932 square foot lot because the first 540 sf of garage areas primarily designed for parking 4-wheeled vehicles is exempt from the overall floor area calculation. The proposed building would reach a maximum height of 12 feet, 3 inches above surrounding grade and the exterior walls would have these setbacks: 9 inches from southern front line; approximately 100 feet from western side line; 10.5 inches feet from northern rear line.
