Hello,

My name is Hilary Diehl and I live in the Sorich Park neighborhood in San Anselmo, at 164 San Francisco Blvd. I am writing on behalf of my husband and myself to express our opposition to re-zoining this property, 404 San Francisco Blvd, from 17 units to 64.

First of all, Sorich Park has a major creek that collects all of the runoff from the hillside. As an advocate for environmental protection it would seem to me that a massive development of that many units would negativly impact the creek, wildlife, and the potential for flooding. Also, this hillside area has a history of wildfire. The area only has one street that goes in and out, San Francisco Blvd., and with the number of people that would house that many units, would create huge safety concern for this large number of people to evacuate the area if there were such a disaster.

Another important consideration is the fact that this location is far from the 101 freeway. It is 3.4 miles and one hour and 7 minute walk. The San Anselmo Hub is a 23 minute walk and much more limited bus schedule. The number of cars on the road would also obviously be a huge strain on our roads, which are already overcrowded. Traffic from the Hub is often backed up to beyond San Francisco Blvd, depending on the time of day. By adding 64 plus cars to this road everyday would be terrible for the environment and the community at large. Also, what would the impact have on our local public schools, as this would potentially increase enrollment.

Please consider this information when determining the fate of 404 San Francisco Blvd.

Message:	While I recognized that the Board of Supervisors has limited flexibility regarding the State mandated housing requirements, I am opposed to any additional housing in Lucas Valley for these reasons. 1. Lucas Valley Road is a two lane road. It is the only egress route for those living in Upper Lucas Valley or the "Estates" and one of only two methods of egress for Marinwood residents. Any natural disaster, fire, flooding requiring rapid evacuation will create a nightmare scenario endangering many lives. 2. Lucas Valley Road is already experiencing back up problems throughout the day due to the new Kaiser facility on Los Gamos. An additional twenty six homes are being constructed on the hillside above Ellen Drive. It is also my understanding that a multifamily project is being considered by the YMCA. These will add to the traffic backup issues. 3. The proposed housing will add a yet to be defined burden to the Lucas Valley Elementary School and Miller Creek Middle School. 4. The design of the additional housing units is not yet settled but it appears that some will be multifamily stacked units that will be completely out of character for the affected neighborhoods. 5. There will be an additional burden placed on the well known water deficiency issues affecting the County. I am sure you are all well aware of these issues but I ask that they are carefully considered and clearly communicated to the State authorities who impose mandates without careful evaluation of the impact on affected neighborhoods. Dear Board of Supervisors,

I am writing in respect to the proposed development in Lucas Valley, namely around Lucas Valley Rd and Jeanette Prandi Way.

We live around the corner and walk our dog daily around this area, and love the peace and quiet and neighbourliness. We love the integration of the elderly peoples' homes and the juvenile hall amidst a calming and natural environment of families of all ages and financial backgrounds. We, of course, wish to preserve such a precious place, and understand the need for low income housing that is congruous with the current community. And, whilst much is being made of the local resident's interests, we wold like to bring to your attention that of nature.

In particular, the wildlife is so wonderful; every year, just in this little lot, we watch deer, coyotes, birds of prey, owls, snakes, hares, rabbit, small rodents - and the other day, a bobcat. The area is graced by ancient trails for both birds and animals, as they feed on creeks, other animals, and/or migrate. There's a heron who comes regularly, and many, many flocks that travel through the valley onto the bay, or through to West Marin, and beyond. The animals cross Lucas Valley R, and come down from the hills, and have been doing so way before the residences in Upper and Lower LV were built.

This pristine land, once built upon, would be a huge loss for these animals. Plus, given the recent rains, it is clear that the natural waterways and creeks that disperse and run through teh ground are required by wildlife - and us all. If this was blocked by concrete, we will create another issue for the new buildings and surrounding land.

Lucas Valley Rd has increased traffic dramatically in the last five years. Any new construction will be an enormous weight on teh current infrastructure, causing so much traffic - it is already busy enough for the local school runs around us. Adding construction vehicles, with constant noise, plus the new residences' transports would be unmanageable. This is a suburban, not urban, district, and thus congestion does not marry with the local environment. There simply is not enough space. Therefore, the numbers of any new dwellings must be kept as low as possible, as well as the height of the buildings, which is no more than a second storey in the entire valley.

And, what of infrastructure issues, such as those of sewage and water use, car parks, and electric/light pollution, tarmac and concrete...if the houses to be built are sustainable, with and from renewable energy, with a low footprint, and can be used as ambassador construction for climate change and new century living, around drought and fire risks, then these units would add enormous value to the county. Marin could be a flag bearer for social and climate conscious new builds, taking into consideration all the human, wildlife and natural habitat considerations.

It is clear the housing build will take place. But, respecting the parameters of the environment is imperative, and certainly not to make a carbuncle of the investment, scar the land for all-time, and create a huge negative living experience amongst the residences.

We trust you will make the right decisions.
