Pursuant to state and local guidelines implementing the California Environmental Quality Act (CEQA), please be advised that the Marin County Community Development Agency will be the lead agency and will prepare an Environmental Impact Report (EIR) for the Marinwood Plaza Project. We need to know the views of your agency as to the scope and content of the environmental information which is germane to your agency's statutory responsibilities in connection with the proposed project. Your agency may need to use the EIR prepared by this agency when considering your permit or other approval for the project. The Marin Community Development Agency-Planning Division has determined that an EIR is required for the project. Therefore pursuant to CEQA Guidelines Section 15060(c) an Initial Study has not been prepared. The property is located at 187 Marinwood Avenue, San Rafael, CA 94903, and is further identified as Assessor's Parcels 164-471-64, -65, -69, and -70. Details of the project sponsor's project description and application, including project design and mapped location, are on file with the office of the Marin County Community Development Agency, 3501 Civic Center Drive, Suite 308, San Rafael, CA 94903-4157, and are available for public review between the hours of 8:00 a.m. to 4:00 p.m., Monday through Thursday.
