Mr. Tejirian introduced Senior Planner Kristin Drumm who manages the development of the ordinance for the San Geronimo Valley Stream Conservation Area.

Ms. Drumm introduced Long Range Planning Manager Jack Liebster, Stillwater Sciences Consultant Maia Singer, PH.D., and Marin Resource Conservation District, Urban Streams Coordinator Sarah Phillips.

Ms. Singer and Ms. Drumm shared a presentation given to the Marin County Board of Supervisors at the August 20, 2019 Public Hearing. The presentation was regarding the 2007 Marin Countywide Plan Final Supplemental EIR with a focus on potential cumulative impacts to salmonids in San Geronimo Valley (2019). Ms. Drumm recommended that the Planning Commission review the administrative record, conduct a public hearing, and adopt a resolution recommending that the Board of Supervisors adopt amendments to Marin County Code Title 22 (Development Code) for the SCA for the San Geronimo Valley.
