Grew up in Marin, moved back here 30 years ago

I have been active in watersheds, wildlife and environmental issues all my life

As a member of the Marin Group Sierra Club, we worked with Supervisor Rodoni and other creek activists to get Measure D defeated and have the San Geronimo golf course converted to public conservation, especially for the coho salmon that come up the creeks to spawn

We know that the San Geronimo Valley as part of the Lagunitas creek watershed contains some of the best habitat for the endangered coho salmon—but it could be better—and with this ordinance, we fear that it could get much worse.

The current draft of the ordinance falls short of providing legally required protection for the coho salmon under CEQA. There are too many exceptions that would allow piecemeal development. This is the death by 1000 cuts that we currently understand is behind so many environmental issues including climate change, plastic pollution, and species extinction that threaten us all.

It's up to us to back away from the cliff, and start putting back the pieces we scrambled and broke in our rush to develop. This ordinance needs teeth, clarity, and the protection of the creek, its setback, the salmon and wildlife at its core.

We support the suggestions of TIRN and SPAWN from their legal team to strengthen this ordinance and protect this precious watershed.

NOTE: I WAS NOT ABLE TO COMMENT VIA TODAY’S ZOOM CALL BECAUSE THE MEETING GOT PUSHED BACK DUE TO INCORRECT POSTING OF CALL-IN CREDENTIALS.
I have lived in Marin for more than 40 years. I currently live in Mill Valley.
I still can remember seeing salmon and steelhead in Mill Valley creeks and in Muir Woods. Seeing

salmon now is very rare. Unwise development and population growth have taken a toll on native habitats throughout Marin County.

Coho are making their last stand in the San Geronimo Valley. It's our chance—and obligation—to save a keystone species.

In the past, as a Board member of Watershed Alliance, and later as a Board member of the Sierra Club Marin Group, I met a number of times with the then-Board of Supervisors to craft a commonsense stream protection ordinance. I also testified at BOS meetings of the necessity to protect stream habitats for Coho. Unfortunately, the County rejected that stream protection ordinance and has done nothing to ensure stream protection despite its stated commitment to do so in its 2007 Countywide Plan and subsequent court rulings requiring compliance with the Plan. It's time to stop playing politics, follow the law and rely on science to save this endangered species and other species that depend on freshwater habitats.

Please close the loopholes that weaken the current proposed ordinance.

Protect for this critical habitat.

Pray for everyone's voluntary cooperation, but ensure enforcement.

My name is Jean Berensmeier. My family moved to Lagunitas after discovering the Valley in 1953. In 1972, I helped and celebrated Giacomini's successful bid for Supervisor. His was the third vote needed to assure passage of the Marin CountyWide Plan. Community Plans followed. I founded the SGV Community Center, the SGV Planning Group and Wilderness Way. I served 20 years on the County Parks and Open Space Commission helping acquire 4 Open Space Preserves totaling 2600 acres in San Geronimo Valley. I am a retired professor of Physical Education.

I'm 89 now and believe . . .

- We must be a strong voice for nature.
- Man and nature need each other. When we hurt one we hurt the other and nature always bats last.
- This long overdue ordinance is one step toward halting the environmental destruction we have allowed to happen since the early 1900's.
- Because humans are amazingly adaptable and nature is astonishingly resilient we have a "little" time to do "the right thing." Our children and their

families will suffer if we fail.

The Planning Commission's job is to protect this gift, a miracle of creation, and use their wisdom to recommend the best plan to the BOS. This is not a gift to possess or to exploit. It is a gift for us to enjoy today and to hold in trust for countless generations that will follow.

Lucky homeowners who live on the creek enjoy this gift but with it comes responsibilities to protect the creek, the fish and their habitat with set back limits, brush and soil removal rules so they can safely return to their natal streams to spawn. Non-creekside owners do not have this gift or responsibility.

Regarding the Draft SCA:

1. Thank you for your efforts to date to effectively mitigate adverse impacts and eliminate inappropriate exceptions and exemptions that allow inappropriate development.
2. The draft needs to be science oriented. Say so. Science will provide the info needed for adequate setbacks, protection of banks and native plants.
3. Recommend adequate staff for ongoing monitoring and annual reports.
4. The draft attempts to provide creekside homeowners some of the benefits a non creekside owner enjoys (500' add on). This is inappropriate. A creekside parcel is not the same as a non-creekside parcel. They are different properties with different characteristics and needs.
5. Building vertical is a key tool to protecting soil and plants while providing homeowners extra space.
6. Exempting ADU's from building standards on creekside properties is unconscionable. The Planning Commission should recommend that the BOS challenge this State requirement as it will be harmful to salmonids.

RE: EXPANDED STREAM CONSERVATION ORDINANCE FOR SAN GERONIMO VALLEY

Dear Commission Members,

The Marin Audubon Society appreciates your attention to our comments below and to the responses to earlier in the staff report. In particular, we appreciate the clarification of the Combining District and the parcel analysis that is provided. We also agree with the need for additional guidance to clarify standards on how staff would apply the exceptions. We continue to have concerns, however, about the following aspects:

- **Pyrophytic Plants** - Links are provided for lists of acceptable plants to use and another for "fire hazardous plants" from Fire Safe Marin which apparently is the official list Marin County will be using. Providing lists of both hazardous and acceptable plants brought to our attention that no replacement plants are required. People apparently can remove large numbers plants deemed to be "fire hazardous", including some native species, and not plant anything to replace them.

This is particularly troublesome because the "fire hazardous plants" list includes three native species. Native plants are part of the ecosystem, provide important habitat for native wildlife and other benefits and we question allowing people to remove them with no review. They are probably not flammable anyway because growing next to a creek they would be well hydrated. We fully support the removal of non-native species on the list.

Another concern is that this exemption has the potential to result in significant erosion and siltation of the Creek. This could occur when the number of non-native species is large enough that their removal could leave an unvegetated area that could erode the following winter, thereby contributing sediments to San Geronimo Creek and degrading the habitats. Even if only one or two plants are removed, the removal process itself could result in significant damage to adjacent vegetation that are not the target species. Because of the risk to native plants, and to stream waters, we strongly recommend that plant removal not be exempted from site plan review. This is necessary to address Impact 5.2 and implement Mitigation 5.2-1.

- **Environmental Assessment** - The initial Site Assessment should include an assessment of trees and other riparian vegetation. And it should include findings regarding environmental impacts and recommendations for avoiding or minimizing impacts.

Environmental Assessment should be ongoing and the required biannual reports are the place to keep track of "the amount of riparian vegetation that remains intact." We strongly support including this information. Either the amount of riparian vegetation that is removed annually and/or the amount that remains (in either case a baseline would be needed), should be collected and reported out in compliance with Mitigation Measures.

Concerns raised in our previous letter about the cumulative impacts of tree removals that take place on individual properties, should also be addressed. The best or only ways to address cumulative tree loss that we see is to require that tree loss be mitigated by planting replacement native trees in their place, in addition to tree removal not be exempted from site plan review, particularly for removal of multiple trees. We recommend that mitigation be provided for all native trees removed, that the tree losses be tracked and an evaluation be part of the biannual report. The biannual report is also the place where the need for further measures should be evaluated, if the cumulative impact is significant.

- Mitigation should be required for riparian and buffer habitat loss and should be provided at a ratio of 2 :1 for native trees removed. We also agree that offsite ration of 3:1 should be required. The existence of a mitigation bank just offers an easy out for persons wishing to remove vegetation. For this and other reasons, MAS has long opposed mitigation banks.
- For Ephemeral Streams there is a requirement for 100 feet of riparian vegetation for it to be considered under the ordinance . This restriction ignores the value of ephemeral streams for water quality and quantity downstream. Furthermore, it is unclear whether the required 100 feet need to be contiguous or even on the property under consideration for development. In our Mediterranean climate where we have no rain all summer, it would not be at all unusual for an ephemeral stream site to lack such extensive riparian vegetation. This requirement should be deleted.
- Purpose of chapter 22.52.010 B. speaks only to preserving the heritage and beauty of and minimizing adverse effects. Since this Creek is part of the Lagunitas Creek ecosystem which is one of the most important endangered salmonid streams in the state, it is important that the purpose statement recognizes that maintenance of the Creek as habitat for threatened and endangered species is an important reason, the most important purpose in our view, for this ordinance.

Thank you for the opportunity to comment and your continued attention to this matter.

The SCA has been proposed as a means to protect, conserve, and potentially repair creek habitats including riparian plants and animals.

The SCA is limited to approximately 1600 homes in the SGV.

I find the gesture of the SCA good intentioned, but completely ignoring one of the main issues affecting riparian and waterway health in the SGV — **which is old, leaking, or failing septic systems.**

Without a solution to this very real issue MORE regulatory burdens on residents that want to improve their properties will not solve the issue. People will choose to thwart the process all together to avoid the revolving door of costly county inspections and permits. And if the county via the SCA relies on inspection of septic at time of sale — that could take decades to get through the 1600 homes in the Valley that may or may not have permitted fully functioning septic.

Homeowners that want ADUs on their property's will forgo permitting because of the septic inspection requirement. And the County will lose the opportunity to create sanctioned affordable housing in one of the most expensive areas in California. In particular in an area with many aging people on limited incomes.

Since efforts to get the SGV onto municipal sewer have gone nowhere, I propose in all seriousness that as part of this ordinance a **special fund is created to subsidize the cost of repairing and replacing SGV home septic systems.**

The fund would be created through grant applications to both State and National resources to improve water habitat, a potential bond initiative, and/or an appeal to the State of California with its approximate \$20-30B state surplus.

A "SGV septic program committee" comprised of at least 1-2 county staff, 1-2 commissioners and 1-2 residents would be formed to fully develop and implement the program.

The approximate cost to create such a fund if one assumes a maximum cost of \$120k per 1600 hundred homes is \$192M plus administrative costs.

The program could be offered to residents to use within the next 5 years (upon funds being secured). If they choose not to use funds for repair, they can use the fund to prove their septic is functioning properly through a one time annual inspection that looks at load calculations and potential leaks. At the same time, if the County doesn't hold septic plans for the property, plans could be developed using the allocated funds. This would satisfy the desire of the county to have existing septic data with proof of an operational system or a repair/replacement to a system if needed.

Any funds not used within the 5 year period for septic improvement would be held for uses pertaining to septic, technical assistance etc. to the benefit of SGV homes/homeowners.

Clearly, many other criteria would have to be determined for such a fund to be fairly allocated— but it is not impossible. I have great faith in the talented people working for the county and to those homeowners who have been advocating in the SGV for years to design and implement a program that would truly help our waterways through improving and repairing the septic systems in the SGV.

I believe I speak for most people in our county, and in the greater San Geronimo Valley watershed, when I say that we all agree in the inherent value of protecting our water quality and the habitat that supports our magnificent, but threatened, runs of Coho salmon and other salmonids such as Chinook and Steelhead. As a former fisheries biologist who worked in stream restoration for the State of California and remains well informed on this topic, it is my belief that the scope of the current SCA proposals could be seen as arbitrary and capricious (20ft setbacks vs 50ft setbacks vs 100ft setbacks) and may not be supported by the science of the issue, but rather seems to have been turned into a targeted attempt to hold individuals accountable rather than focusing on the larger systemic problems creating negative impacts.

Healthy runs of salmon are in themselves a valuable wildlife and cultural resource, but they are also indicators of the greater health of the entire ecosystem that supports them. We humans are inextricably a part of that ecosystem, but our collective impacts are far greater than those that can be immediately quantified by and attributed to the some odd 800 home owners that immediately abut the San Geronimo/Lagunitas creek system.

Tree cover and riparian vegetation are incredibly important for shading and water temperature regulation, especially for cold water species like salmonids, and bank stabilization is significant not only for protection of property but to keep the amount of fine sediments from filling in stream gravels that are critical for salmonid spawning. While there is an argument for more stringent guidelines to keep development from impacting these site-specific attributes, this impact is not the same as the relatively small affects from, for example, the building or repairing of a homeowners deck which seems to be limited in the proposed SCA rules.

Saddling individuals alone with the costs and burdens of a broad brush approach to watershed management and a relatively arbitrary SCA distance (no two properties are alike and nor are their levels of disturbance) is both shortsighted and distracting from the larger efforts needed at the systemic level by the county, State, and Federal government and all of those who use and pass through our watershed.

Where are the proposals to install curb and gutters on all of the main county roadways that lead stormwater and runoff to the stream? Where are the proposals for settling basins and bio swales at the outflow of culverts that direct and filter not only sediment but all manner of oil, gasoline, and tire crumble from the roads we all use? A recent scientific paper on Pacific Northwest streams points to the impacts of rubberizing chemicals from tire crumble that are impacting the endocrine systems of salmonids and thereby decreasing fertility. But do we see regulations proposed for tires? Not so. Instead it is the homeowners that live along the stream that must solve this issue.

Best management practices (BMP's) like those instituted as a conservation measure for the greater Lake Tahoe area, total lot coverage, erosion control etc, are successful when exercised first at the public works level and then the community level but not either-or.

This is a contentious issue for many residents of the San Geronimo Valley and before implementation of a policy that may look good on paper, I believe it needs more science guidance and proper weight attributed to the larger systemic issues over the relatively small impacts of individual land owners.

In this story we are all the villains. Human activity is undoubtedly a factor in in the greater demise of indicator species such as salmon. Habitat destruction and historic over harvest are both to blame, but looking to successes like the dam removal and restoration of Roy's pools is reason for hope. In my world view the county should be incentivizing land owners to restore and protect the watershed, with efforts like native tree planting, rather than solely passing restriction that alone cannot and will not accomplish the expressed goal of this exercise, to save the salmon and encourage a healthy environment for all manner of wildlife and human life.

The categorical exemption for removal of plants identified as pyrophytic by the Marin Fire experts (item #10 in the Staff Memorandum) is not based on sound botanical science. With all due respect to Marin Fire, the inclusion of native bay laurel trees is based on a flawed understanding of their risk of transmitting phytopthera to oak trees, causing oak death. The recommendation of the University of California experts on managing phytopthera (link attached) are against wholesale removal of bay

laurel trees in residential settings. Instead, the recommended action is for selective pruning where bay laurel trees are in proximity to oaks.

The importance of riparian vegetation and shade for the threatened salmonids in San Geronimo creek is well documented. Bay laurel trees are an important part of that vegetation, and they are not, by themselves, a fire hazard in a riparian habitat. Their removal from the creek area should be subject to review to determine if they are any threat to transmit phytophthora, and to determine if less drastic measures, such as pruning, can reduce the risk of transmission.

Re: Stream Conservation Ordinance

Dear Commissioners:

Marin Conservation League supports adoption of the Expanded Stream Conservation Ordinance for the San Geronimo Valley, including provisions for a combining district with the stated specific development standards, site plan review and assessments, including allowable exceptions to the SCA requirements.

The November revision has incorporated a number of changes that we believe are improvements over earlier drafts. However, we ask consideration or clarification on several points:

- The staff memorandum has a more detailed explanation of how the 500 sf allowable allowance could be calculated than the ordinance has, including what it includes and excludes, though this is awkwardly stated. The ordinance itself would benefit from a more amplified description of exactly what the 500 foot exception means.
- The list of allowable land uses, subject to the combining district and within the SCA, in draft section 22.30.045.D.4 should include “bridge” or “waterway” before “crossings” to enhance clarity.” E.g. line should read “Driveway, road, bridge, and utility crossings, if no other location is feasible.”
- The explanation in the memorandum on possible implications of SB 9 on development potential in the San Geronimo Valley is helpful. Please clarify if the estimated increase in the number of improved parcels within the SCA includes any possible increase enabled by SB 9.
- In site plan review exemptions (22.52.030) MCL recommends that native trees with considerable habitat value, such as California bay laurel, and pyrophytic vegetation are included on the list as exempt from site plan review. Site assessment should document presence and assess value of all trees for habitat, climate moderation, and other environmental functions, and make every effort to retain valuable vegetation.
- Rigorous enforcement of the ordinance will be important to maintaining public support for its provisions. In that respect, MCL supports a tiered inspection program, as suggested in the

ordinance, to avoid the risk that non-compliant modification/construction might proceed to completion before being observed.


- The standard for protection as an ephemeral stream should extend to all streams with 100 feet or more of riparian vegetation whether the vegetation is in one continual stretch or is discontinuous. Given the tendency of these flashy channels to occasionally meander in storm events, setbacks are important not only for habitat protection, but in some instances for property protection
- Utilize the US Fish & Wildlife Service classification for wetlands, rather than the more restrictive USACE one. The USFWS classification, based on the Cowardin definition, would provide that unvegetated or sparsely vegetated areas, such as our seasonal wetlands, be defined as wetlands. This provision is notably applicable to Marin County where there is a long dry season in which vegetation appears to have disappeared. This defines wetlands as having one or more of three attributes, rather than all three, as required by the USACE.

We understand that successful application of SCA requirements will rely on the thoroughness and integrity of the site assessments. Staffing for this activity should be permanently secured and have sufficient resources and expertise to provide reliable planning guidance. The goal should be both improved protection of resources and secure property value.

Dear Kind People- I have lived on the creek in San Geronimo for 42 years and know the stream well. I have 2 points to make about this issue- the SCA Ordinance and Resolution.

#1 Any effects of any requirements about the stream that affect this water system need to be vetted by Peer - Reviewed Scientific Research, not just one report or anything less than this rigorous review procedure. We wouldn't accept it for any of our Covid vaccinations affecting our lives, nor should we accept it for any of these proposals that affect out properties.

#2 This creek is many things to many animals- salmon, trout, river otters, deer, etc.- and people alike. The overriding reality here is that it is also the main rain water drainage system for the entire San Geronimo Valley. The County of Marin's county-wide flood control responsibilities are primary here in protecting our properties from damage that will be caused by flooding. Re: Stream Conservation Ordinance

Dear Commissioners:

Marin Conservation League supports adoption of the Expanded Stream Conservation Ordinance for the San Geronimo Valley, including provisions for a combining district with the stated specific development standards, site plan review and assessments, including allowable exceptions to the SCA requirements.

The November revision has incorporated a number of changes that we believe are improvements over earlier drafts. However, we ask consideration or clarification on several points:

- The staff memorandum has a more detailed explanation of how the 500 sf allowable allowance could be calculated than the ordinance has, including what it includes and excludes, though this is awkwardly stated. The ordinance itself would benefit from a more amplified description of exactly what the 500 foot exception means.
- The list of allowable land uses, subject to the combining district and within the SCA, in draft section 22.30.045.D.4 should include “bridge” or “waterway” before “crossings” to enhance clarity.” E.g. line should read “Driveway, road, bridge, and utility crossings, if no other location is feasible.”
- The explanation in the memorandum on possible implications of SB 9 on development potential in the San Geronimo Valley is helpful. Please clarify if the estimated increase in the number of improved parcels within the SCA includes any possible increase enabled by SB 9.
- In site plan review exemptions (22.52.030) MCL recommends that native trees with considerable habitat value, such as California bay laurel, and pyrophytic vegetation are included on the list as exempt from site plan review. Site assessment should document presence and assess value of all trees for habitat, climate moderation, and other environmental functions, and make every effort to retain valuable vegetation.
- Rigorous enforcement of the ordinance will be important to maintaining public support for its provisions. In that respect, MCL supports a tiered inspection program, as suggested in the

ordinance, to avoid the risk that non-compliant modification/construction might proceed to completion before being observed.


- The standard for protection as an ephemeral stream should extend to all streams with 100 feet or more of riparian vegetation whether the vegetation is in one continual stretch or is discontinuous. Given the tendency of these flashy channels to occasionally meander in storm events, setbacks are important not only for habitat protection, but in some instances for property protection
- Utilize the US Fish & Wildlife Service classification for wetlands, rather than the more restrictive USACE one. The USFWS classification, based on the Cowardin definition, would provide that unvegetated or sparsely vegetated areas, such as our seasonal wetlands, be defined as wetlands. This provision is notably applicable to Marin County where there is a long dry season in which vegetation appears to have disappeared. This defines wetlands as having one or more of three attributes, rather than all three, as required by the USACE.

We understand that successful application of SCA requirements will rely on the thoroughness and integrity of the site assessments. Staffing for this activity should be permanently secured and have sufficient resources and expertise to provide reliable planning guidance. The goal should be both improved protection of resources and secure property value.

Thank you for the opportunity to comment and your continued attention to this matter.

The SCA has been proposed as a means to protect, conserve, and potentially repair creek habitats including riparian plants and animals.

The SCA is limited to approximately 1600 homes in the SGV.

I find the gesture of the SCA good intentioned, but completely ignoring one of the main issues affecting riparian and waterway health in the SGV — **which is old, leaking, or failing septic systems.**

Without a solution to this very real issue MORE regulatory burdens on residents that want to improve their properties will not solve the issue. People will choose to thwart the process all together to avoid the revolving door of costly county inspections and permits. And if the county via the SCA relies on inspection of septic at time of sale — that could take decades to get through the 1600 homes in the Valley that may or may not have permitted fully functioning septic.

Homeowners that want ADUs on their property's will forgo permitting because of the septic inspection requirement. And the County will loose the opportunity to create sanctioned affordable housing in one of the most expensive areas in California. In particular in an area with many aging people on limited incomes.

Since efforts to get the SGV onto municiple sewer have gone no where, I propose in all seriousness that as part of this ordinance a **special fund is created to subsidize the cost of repairing and replacing SGV home septic systems.**

The fund would be created through grant applications to both State and National resources to improve water habitat, a potential bond initiative, and/or an appeal to the State of California with its approximate \$20-30B state surplus.

A "SGV septic program committee" comprised of at least 1-2 county staff, 1-2 commissioners and 1-2 residents would be formed to fully develop and implement the program.

The approximate cost to create such a fund if one assumes a maximum cost of \$120k per 1600 hundreds homes is \$192M plus administrative costs.

The program could be offered to residents to use within the next 5 years (upon funds being secured). If they choose not to use funds for repair, they can use the fund to prove their septic is functioning properly through a one time annual inspection that looks at load calculations and potential leaks. At the same time, if the County doesn't hold septic plans for the property, plans could be developed using the allocated funds. This would satisfy the desire of the county to have existing septic data with proof of an operational system or a repair/replacement to a system if needed.

Any funds not used within the 5 year period for septic improvement would be held for uses pertaining to septic, technical assistance etc. to the benefit of SGV homes/homeowners.

Clearly, many other criteria would have to be determined for such a fund to be fairly allocated — but it is not impossible. I have great faith in the talented people working for the county and to those homeowners who have been advocating in the SGV for years to design and implement a program that would truly help our waterways through improving and repairing the septic in the SGV.

Dear Chairman Holland and Commissioners:

Thank you for the opportunity to comment on the draft Stream Conservation Ordinance. Marin Audubon applauds the Planning Staff for the extensive outreach on this ordinance. We strongly support the ordinance because it is essential to protect our creek resources and enhance or restore degraded streams. Our comments below are intended to clarify language where it is unclear and to strengthen the ordinance to ensure the intended purpose is carried out.

22.33.101 Purpose

The purpose statement should be expanded to include a more complete explanation of the purpose of and the many benefits streams and their associated vegetation provide. The purpose should be considered a means to educate the public about the need for and importance of freshwater streams and the benefits of the ordinance. In that light, we suggest expanding the list of benefits to include: stabilizing streambanks, preventing erosion and downstream sediment transport; providing nesting, feeding and movement corridors for birds and other wildlife; providing food and shade for fish; recharging groundwater; moderating climate; as well as increasing property values.

22.33.030 A. Requirements

1. Explain how feasibility will be evaluated. How will be determined that avoidance is not feasible? Will the evaluation be on the basis engineering/construction feasibility, economics, aesthetics, etc.?

3. Add as d. "Adverse impacts to fish or wildlife" to the list of impact that would prohibit development in SCA's.

B. SCA setbacks

3. Include some examples of when an additional setback would be required. At minimum, additional setback should be required to avoid impacts to endangered species.

4. Riparian vegetation rarely if ever extends for a continuous length of 100 feet on ephemeral streams. Setbacks should still apply for ephemeral streams regardless of vegetation because ephemeral streams are the headwaters of our creeks. Loss of these stream lengths, which filter, aerate and assist in flood protection, would impact water quality for the entire downstream reach.

Chapter 22.63.020

We support the Application of SCA provisions, but we have problems with some of the exemptions:

B. Exemptions

1. g. should include a provision that maintenance and repair of permitted or legal non-conforming uses should not expand the footprint of the structure.

h. Replacement of non-native invasive vegetation should not be exempted.

2. b. Define "previously disturbed area" so that it does not include areas that have simply been cleared, graveled, replanted, etc. e.g. not an area that could be restored fairly easily. Only areas that are developed with structures should be covered.

22.63.030 Stream Conservation Area Permit – development activities eligible for Tier 1 consideration

A. Tier 1

1. The wording should be clarified so that the ability to have a 500 foot addition to an existing structure is limited to one time. This is essential to prevent repeated incursions which would have significant cumulative impacts and would defeat the purpose of the ordinance.

7. This provision includes the requirement that water supply and flood control projects be necessary, yet the list for Tier 1 includes a number of other activities that could have just as damaging, if not more, impacts on riparian resources. All of these exempt activities, (which include decks, patios, paths, and roads) should have to prove that it necessary for them to be located in the SCA.

B. 2. a.

2.a. The provision allows for removal of riparian vegetation, provides for replacement, and that the replacement vegetation "may" consist of native species. We recommend that Tier 1 activities be required to demonstrate that they cannot be placed in a location where they would not remove native vegetation except on a temporary basis. Also all replacement vegetation should be required to be with native riparian species. Necessary roads or paths should be required to be constructed of impervious surfaces.

22.63.040 Tier 2

B. 2. a. What would constitute a "more appropriate" mitigation? What criteria would be used to make this judgment? The criteria should be based on benefits to the resources at the site of loss and should not be located some distance away where it might be cheaper and more convenient.

C. Mitigation Criteria

Only replacement mitigation, i.e. options for alternative mitigation" is addressed under this heading. The Site Assessment should be required to address avoidance of the impact, i.e. whether it is possible to avoid intrusion into the SCA and how that could be accomplished, before other options are addressed.


- We agree with the stated criteria and recommend adding the following:
- Offsite mitigation should only be allowed when it is impossible to provide on-site mitigation. Any] off-site mitigation off site should be close to the site of loss.
- Mitigation measures should be required to be permanent

Additional Suggestion:

One way the county can educate the public about the value of stream resources is to encourage residents to restore their creeks by offering small grants to revegetate their SCA's with native riparian vegetation and other activities that would benefit riparian resources.

San Geronimo Valley Stewards thank the Planning Commissioners and staff of Community Development Agency for their thoughtful consideration of the stream ordinance and conservation program for San Geronimo Valley. The facilitator meetings were useful, and the November 8 workshop raised important issues.

Before the Planning Commission votes on a Resolution December 13, SG Valley Stewards request there be added to the Resolution, the ordinance or the Exhibits the following improvements which will incentivize voluntary compliance by the hundreds of homeowners who live near the streams.

Each of the improvements we request is consistent with the Final SEIR, the 2007 Countywide Plan, and Court orders.

1. Reduce or subsidize costs for homeowners.

If salmon habitat is so important to the County and its citizens, the public should pay for the costs to comply with the FSEIR and Court orders. The burden of saving Marin's coho fish should not fall on only 800 families in San Geronimo, whose homes are mapped within the stream conservation area.

Exhibit C tells us Marin RCD will perform Site Assessments at the County's expense. CDA staff stated Nov. 8 there would be no fee for Site Plan Review. But \$3885 is estimated to be the Site Plan Review Application Costs, in Slide 25 of Nov. 8.

How much must we pay to comply with the stream ordinance?

2. Divorce septic inspections from the stream program.

Current Community Development Agency practice is to require a septic inspection for every permit application, even for projects not related to septics.

The stream ordinance should carve an exception to this agency practice.

The septic inspection itself is expensive. If the inspection shows a defect, septic repair or replacement can cost \$50,000 to \$120,000. This is unaffordable and results in civil disobedience.

People will not apply for a stream Site Assessment or Site Plan Review, with the overhanging threat of a septic inspection. They will simply do their project without a stream assessment. CD Agency acknowledges that about 75% of the projects in

West Marin are done without permit, for fear of septic inspections.

We should not repeat this mistake in the new stream ordinance.

The stream Ordinance should state: "No septic inspection shall be required for any Site Assessment under chapter 22.30 or Site Plan Review under chapter 22.52, unless the property owner proposes a project directly related to repair, maintenance, replacement, or construction of a septic system."

3. SMP's--Homeowners Need Free Workshops and Fire Prevention

The ordinance requires all projects comply with Standard Management Practices (SMP's Exhibit D). The SMP's are the guts of the stream program. More attention is needed to costs and delays caused by these detailed requirements. The County should offer free workshops with knowledgeable staff to explain "how to do your project".

What is missing from the SMP's? FIRE! The SMP's omit any requirement that projects comply with fire prevention, defensible space, state law and local fire regulations. Instead, the SMP's would require each owner to plant NEW shrubs, grasses and trees in our wildfire-prone landscape, which would compete with our old growth oaks and redwoods.

Fire safety and preserving old growth conditions in our Valley forests are the most important management practice for our riparian ecology.

The ordinance should be amended to allow property owners to trim and remove vegetation and trees, without site assessment or site plan review, where necessary to create defensible space and fire resilient forests.

The SMP's should include fire safety guides published by Marin County Fire Dept. and Marin Wildfire Prevention Authority. Property owners must obey local fire agencies guides under California Public Resources Code 4291 and 4291.1.

4. Encourage Affordable Housing, Clarify Stream Rules for ADU's

Can a small accessory dwelling unit be built within the stream conservation area?

Only a Category 1 ADU, or also Category 2 or 3? Does it require stream site assessment? Does it require stream site plan review? Is the stream ordinance (which requires discretionary review) consistent with new state laws?

Four separate sections of the stream ordinance give different answers to these questions. Compare sections 22.52.040 and 22.30.045 A. 2 and Exhibit C (discretionary review in the SCA) with 22.32.120 A. (no discretionary review for Category 1 ADU's).

Compare sections 22.06.050 and 22.52.030 (seem to allow ADU's in the SCA) with section 22.30.045 A. 3 (land uses not listed are prohibited in SCA).

Please fix the drafting.

5. Locate Streams and Parcels With the New Lidar Stream Map

MarinMaps website is challenging to navigate. The County should publish a short guide for how the homeowner can locate his parcel.

The stream map should more accurately measure the stream conservation area from the center of the stream, not the "top of bank" which does not appear on the map and makes no sense where the stream bank is a steep hillside.

The County should determine how many residential parcels are fully within the SCA, and how many are partially within the SCA.

Vacant parcels in the SCA should be labeled, so we can see whether any of them have the potential for future development or whether they are unbuildable because smaller than 3,000 SF. Many unbuildable "paper lots" are left over from the early 20th century.

6. Annual Monitoring, Public Reports, and Sunset After Year 2025.

The County should publish a report each year on the number of stream site assessments requested, the number and types of projects for which stie plan review was approved or denied, appeals and dispositions, and whether there is measurable improvement in salmon populations as a result of these new rules.

We already have 30 years of MMWD fish count data for San Geronimo creeks. Over 10,000 per year smolts survive in our creeks but do not return as adults because they die in the ocean. Fish counts show the timing and amount of rainfall determines the number of salmon in each 3-year class.

After 3 years experience with the new stream rules, the county should take a fresh look at the results--for humans and fish. The stream ordinance should sunset after 3 years, unless noticeable improvements are measured by year 2025.

The most significant impact on salmon is clearly demonstrated as due to lack of enough Fall rain (as opposed to activity within 100 feet from streams). Please change the SCO to a 35 foot setback from the MarinMap center of all intermittent streams and a 20 foot setback from the MarinMap center of all ephemeral streams (regardless of ambiguous top of banks and riparian vegetation).

Dear Commissioners,

I am a lifelong resident of Marin County and a retired aerial firefighter. I have served as an airtanker pilot for CALFIRE, the State of North Carolina and the U.S. Forest service during my 35-year career. During that time, I have observed, first hand, that the intensity and frequency of wildland fires has increased markedly over that period. I've had a ring side seat at catastrophic and devastating wildland fires and witnessed things that I wish I hadn't seen. I have been on fires where whole communities were consumed by wildfire. I have been overhead when Citizens and Firefighters were overrun and killed by fires that spread faster than a person can run. I was over the Oakland fire feeling nearly helpless as I watched the total destruction of thousands of homes and knew that lives were being lost beneath me. On every trip between the fire and the airtanker base at Santa Rosa I looked over at Marin praying that another wind driven fire wouldn't start there because the same deadly conditions that were driving the fire in Oakland were also prevailing in Marin. All that was lacking was ignition.

As a lifelong resident of Marin County in the San Geronimo Valley my concerns for the safety of our Citizens and Firefighters has also increased greatly as conditions continue to worsen. Marin County has at least ten "Paradise Fire" scenarios contained within our borders. My fear is that in a "worst case scenario", evacuation and rescue from our hillside communities will be problematic at if not impossible.

Marin County has done a lot of good work clearing fuels along thoroughfares that might have to serve as evacuation routes. Our fire officials are doing a good job of identifying and remediating trigger points and hazardous conditions in our communities. In spite of these efforts the risk of entrapment looms large in the face of a wind driven fire that broadcasts embers and firebrands far ahead of the main fire, starting new fires everywhere in its path. This necessitates the need to identify and improve safety zones where people can shelter in place in order to survive such an event.

Increased emphasis must be place on reviewing vegetation ordinances that conflict with county and state edicts that require the maintenance of defensible space around homes and businesses. I refer you to the after-action reports on the Angora fire that devastated an entire community located in South Shore Lake Tahoe. It cited the lack of defensible space as a contributing factor in the loss of so many homes. Vegetation ordinances that existed at that time restricted citizens for creating effective defensible space around their homes.

Thank you for your consideration in this urgent matter.

SEPTIC INSPECTIONS WILL DISCOURAGE STREAM SITE ASSESSMENTS

We request the SCA Ordinance state:

"No septic inspection shall be required for any Site Assessment or for Standard Management Practices under Chapter 22.30, or for Site Plan Review under chapter 22.52, unless the property owner proposes a project or development directly related to the repair, maintenance, replacement, or construction of a septic system."

Background

San Geronimo Valley Stewards represent many of the 1,600 families with homes located on San Geronimo Valley. Each house has a septic system. There is no municipal sewage system in the Valley. For decades we have been plagued by expensive septic repairs and testing. Our concerns about creek pollution have generated proposals for a community-wide system, but that seems to be making little progress.

A recent article in the Nov. 11, 2021 Point Reyes Light confirms what we long suspected --over 75% of the building projects in West Marin are done without permit. Why? Because Marin County requires septic inspections for all building permits--including for projects not related to or contributing to septic use.

Please see the attached article for comments by Supervisor Rodoni and Director Tom Lai.

When the County requires a project to include a new septic system, the cost can exceed \$50,000 to \$120,000 for a single family home. This is economically out of reach for most Valley families. So they simply withdraw their permit application and build without permit. Director Lai acknowledges the practice of linking septic inspection to every unrelated project creates "unnecessary surprises for property owners and it has the tendency to push work underground . . ."

The new Stream Conservation Area Ordinance should prohibit using Site Assessments or Site Plan Review as a trigger for septic inspections. According to the Point Reyes Light article, the County website explains that every building permit application may require a septic inspection. We don't know if this is explicit Department policy or merely informal practice. We were unable to find this on the CDA website, although we searched the 5 "Guides" and the 27 separate "Fact Sheets and Resources" on the CDA website.

Stream Site Assessments Should Not Be Stuck in the "Revolving Door" of Septic Inspections

The SCA Ordinance goals of ending litigation and encouraging voluntary compliance will be destroyed if the Departments are allowed to use septic inspections as part of stream site assessments and site plan reviews. No family will open their property to

Marin RCD for a Site Assessment, nor will they apply to the CD Agency for Site Plan Review, if it leads to a septic inspection.

Please consider that the only projects allowed in the SCA under the ordinance will be very small--less than 500 square feet. Some projects within the SCA may not require a building permit. Consider the family adding a garage, or driveway, or tool shed, unrelated to septic use. Would the family risk a \$50,000 septic cost to obtain site plan approval for such a small improvement? NO. They will make the small improvement without creek site assessment.

The new stream rules propose to experiment on 1,600 families in San Geronimo. The experimental theory is that strict rules for houses along the creeks will somehow increase the salmon population, despite the high mortality rate salmon experience in ocean conditions.

Valley homeowners want this experiment to succeed. We want the County to publish annual reports that demonstrate measurable results. The County wants homeowners to voluntarily comply, without litigation and complaint-based enforcement.

The new SCA Ordinance cannot solve the decades-old problems of 8,000 septic systems in West Marin. Don't make the SCAO do something it cannot do. The Department practice of requiring that a building permit include a septic inspection is sufficiently discouraging.

Encourage Homeowners to Comply with Stream Rules.

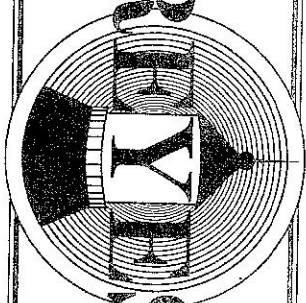
Neither the streams nor the septic systems in San Geronimo will be improved if County agencies are allowed to use SCAO site assessment, standard management practices, or creek site plan review as the back door to septic inspections. People will not comply with either the stream rules or septic regulations. They will continue their home projects with no oversight.

Septic could see reviews at time of sale

Marin County is weighing a major change to the way it regulates septic systems. The county's Community Development Agency is considering an ordinance that would require properties to undergo septic inspections when they change hands, in an effort to gather more records and discourage unpermitted construction.

The agency's Environmental Health Services division has no records for 30 percent of the county's roughly 8,000 septic sys-

tems, so it uses building permits as an opportunity to review them. West Marin property owners often dread the septic review that could come with any permit, so many choose to dodge the permitting process altogether.

"For years, if you get a building permit in unincorporated Marin, you get stuck in the septic revolving door," said Supervisor Dennis Rodoni, who ran a construction company for 38 years. "Is that the proper mechanism to resolve

our lack of data on septic systems? So far it doesn't work that well because people avoid it by not getting permits to work on things."

County officials estimate as much as 75 percent of work in unincorporated Marin is done without a building permit, and scrutiny of septic systems is a major driver. The county will often ask for an inspection as a condition for a building permit, even if the project doesn't make any changes to the septic system. On the county website, septic system permitting guidelines explain that "each building permit application received may potentially require a septic evaluation."

Community Development Agency director Tom Lai, who is proposing the resale ordinance, said it would help his agency move away from seemingly random inspections for projects like fences. "The problem with that approach is it creates unnecessary surprises for property owners, and it has the tendency to push work underground," Mr. Lai said. "They just withdraw the permit application and do it anyway."

Jessica McIsaac, who runs Pasture Fresh Eggs on the McIsaac dairy, made sure to apply for the necessary permit to build a new loafing barn. The barn will not add to the dairy's water use or affect its existing wastewater systems, but the county has no septic records for her family's Tomales dairy, where most of the structures predate regulations, and it used the opportunity to review the systems.

"My building has no toilet, it has no po-

table water, yet I couldn't get the permit without going through a septic review," Ms. McIsaac said. "There was no reason to bring septic into the situation."

Mr. Lai cited the McIsaac dairy example as the kind of situation he is looking to prevent in the future. The dairy's septic systems might be dated, he said, but not necessarily in poor shape. "The new generation has to face the fact that E.H.S. wants to look at their septic system, when they just wanted a new barn," he said. "I really felt bad for them."

Mr. Lai hopes to put an end to what he described as "gotcha moments" by moving septic inspections to the time of sale, when he says the extra costs involved won't be as difficult for property owners to stomach. "At the time of sale, it's a lot of money on the table," he said. "It's going to be less of a surprise."

Ms. McIsaac said the new system wouldn't push as many rural property owners to work without permits. "It would benefit rural Marin County to move forward with removing septic review from a permit that doesn't involve septic," she said. "It would allow more people to legally obtain permits."

Ms. McIsaac is not the only West Marin farmer whose building plans have recently been hindered by unexpected septic review. Bivalve Dairy co-owner John Taylor is using funding from multiple sources, including the State Water Resources Control Board, to overhaul the manure management system in an existing barn.

The dairy currently uses 10,000 gallons of water every day to flush out manure, which then goes into a waste stabilization pond, where it becomes a significant source of greenhouse gas emissions. The dairy's new project will use barn-cleaning robots to scrape manure into a gutter, where newly built equipment will turn it into compost that can be reapplied to pastures.

When the county granted Mr. Taylor his permit last year, E.H.S. required an inspection of the farm's eight septic tanks, five of which are connected to farm-worker housing units. Mr. Taylor saw the county's environmental health concerns as misplaced because of the environmental benefits of the barn project, which he described as a "double win" for carbon sequestration and water usage.

"This project has zero to do with septic," Mr. Taylor said. "But it gives the county an opportunity to come in and look."

One of the project's funders, the Marin Resource Conservation District, helped handle compliance with the septic review, but Mr. Taylor said the work was delayed "pretty significantly."

Mr. Taylor argued that since his tanks are maintained by the private company City Sewer Service, they shouldn't require any government review at all. But he said he would support a resale ordinance in place of the current system, with some flexibility for property owners. "We need to have a workaround" for the current system, he said.

An inspection requirement for every property sale comes with some obvious

drawbacks for anyone selling property. Sewer lateral inspections are required by sanitary districts in Marin's towns, but the county has no such requirement for septic systems, meaning that property sales in unincorporated areas currently come with minimal requirements.

"We're always cautious about items, requirements, or fees that are added at the point of sale," said Romeo Arrieta, chief executive officer of the Marin Association of Realtors. He said his group expects to meet with the county to discuss the idea, which he argued could delay sales and cause stress and expenses for buyers.

Mr. Arrieta also raised doubts about the effectiveness of a resale ordinance. He said the homes that sell may not be the ones with the worst septic problems, so the ordinance wouldn't be well targeted. He also argued that it could take decades for all the houses in a given area to sell, so the septic information would trickle in slowly.

But Mr. Lai said a resale ordinance would make the home-buying process more transparent and consumer-friendly, because buyers would know what kind of septic repairs might be necessary in advance. He said buyers could then negotiate the home price with the seller to factor in the repair costs, and work with the county on a "path to compliance."

The onus is currently on buyers to do their own research, and people often unknowingly buy properties with failing septic systems, Mr. Lai said. The county recommends prospective buyers hire a registered environmental health specialist or civil engineer to look over the property's wastewater system, but it doesn't require such a review.

Any ordinance would undergo public input and face a vote by the Board of Supervisors, which Supervisor Rodoni said could turn into a rocky process. "Septic is a pretty controversial subject in our rural communities out here," he said. "I'm not certain that [Mr. Lai] is proposing exactly the right thing."

But the supervisor agreed the situation needs to change, and a resale ordinance could be a better alternative than biennial inspections for all properties, a solution proposed by the San Francisco Bay Regional Water Quality Control Board.

The county is considering the new ordinance as state regulators review its comprehensive plan for new and failing septic systems, the Local Agency Management Program, or LAMP. The program, which has gone back and forth between the state and the county for five years, is the county's response to Assembly Bill 885, which was signed by Gov. Gray Davis in 2000. The bill and a subsequent regional water quality control board resolution established standards for regulating septic installations, repairs and modifications.

Marin's LAMP is largely a written description of the county's existing policies for new septic construction, and it doesn't concern existing, operational septic systems. But Mr. Lai said it brought renewed focus on those systems from his agency.

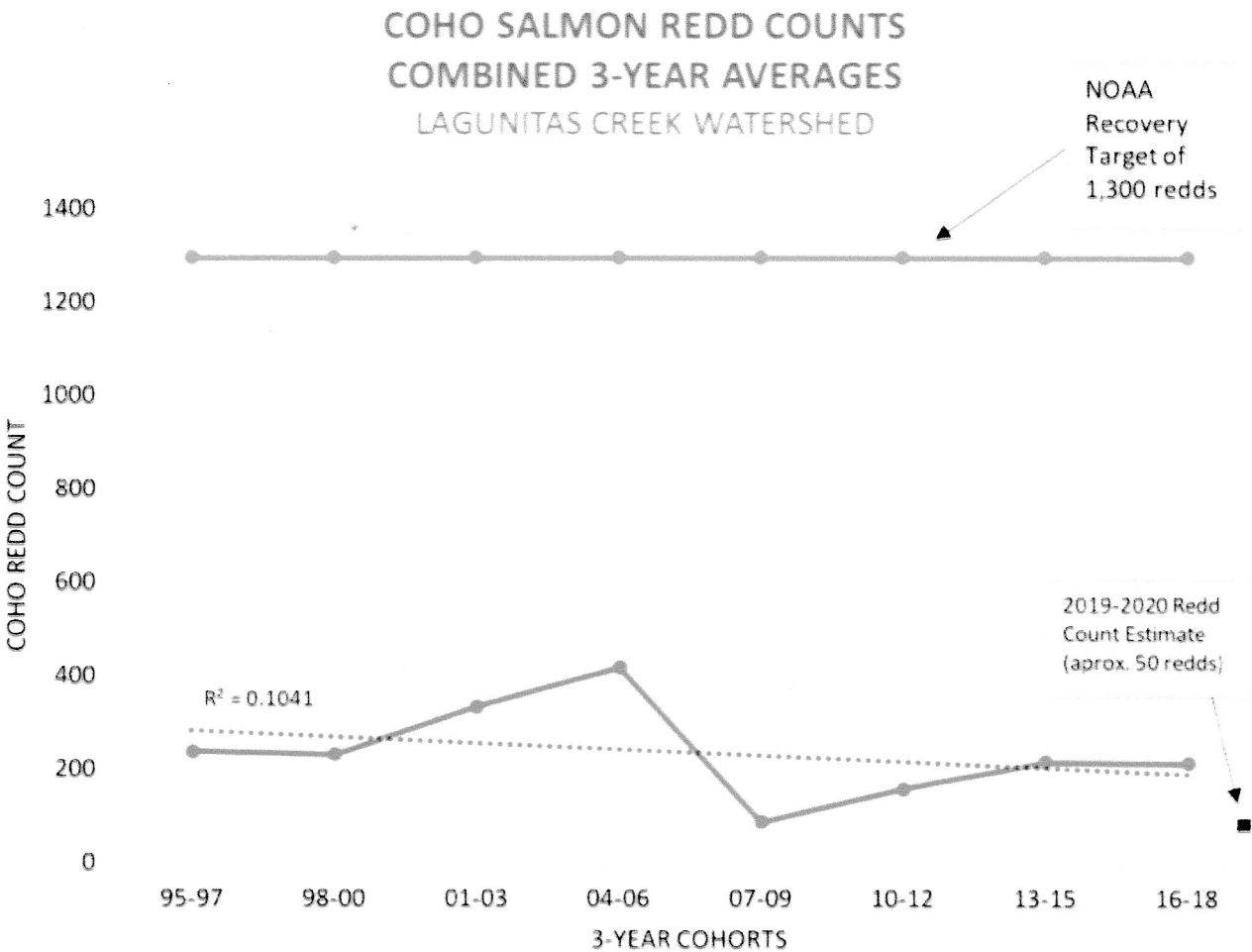
