PENALTIES

Annual Business License Tax is due and payable in advance of July 1 and is considered delinquent on August 1.

Thereafter, late payments are subject to **10%** penalty per month, not to exceed **50%** of the tax.

Flat rate licenses are payable in advance of the business activity. Any flat rate license tax which has not been paid will be assessed a penalty of **25%** in addition to the amount due.
