Several years ago, the Board of Supervisors requested my office make recommendations to enhance security in the building. One of the alternatives was to make the Civic Center a geographical walking patrol beat. This would accomplish two things; one, it provides visible security, and two; it would provide two-teamed deputy sheriffs to respond to potential problems. Non-sworn security officers have no police powers. If they came upon or responded to a problem, they wouldn't really be able to do much more than an employee. That would be to pick up the telephone and call our Dispatch Center.


