Please find the Las Gallinas Valley Sanitary District's (District) response regarding the Marin County Civil Grand Jury Report: 2015-16 Web Transparency Report Card: Bringing Marin County's Local Governments to Light

F2. Inspecting the Marin County Clerk's Roster of Public Agencies, the Grand Jury discovered a majority of local agencies out of compliance per California Government Code §53051 (no filings or outdated filings).

The District has researched and confirmed that the last Statement of Facts form submitted to the Secretary of State was January 31, 2013. The District also confirmed it has been several years since a copy of the Statement of Facts Roster of Public Agencies was sent to the Marin County Clerk.

R2. The agency should file and keep updated its Statement of Facts with the California Secretary of State and the Marin County Clerk as required by California Code §53051.

The District has completed the Statement of Facts Roster of Public Agencies form and sent it to the California Secretary of State on April 7, 2016. A copy of the filed document has been received from the Secretary of State and forwarded to the Marin County Clerk's office.

District Staff has incorporated a procedural change to ensure that the Statement of Facts Roster of Public Agencies Form is filed with the Secretary of State each time there is a change in Board officers or members and a copy of that filed document is delivered to the Marin County Clerk.
