R1:

The agency should improve its web transparency score to "B-" or (or better) by updating its website and submitting the appropriate self-evaluation form. The form may be obtained by emailing grandjury-audit@marincounty.org.

Response: Agree

A self-evaluation form has been submitted and is attached to this response. Additionally, to support ease of viewing and access, the content of the self-evaluation form is available below in *Table 1*.

San Rafael City Schools believes that transparency is important and we strive to provide information that is open and accessible through many communication channels, including our website. We found the Grand Jury's best practices and checklist helpful for providing information that is transparent and accessible, and we used it as a guide in making several updates to our site. As noted in our transmittal letter, some of the information the Grand Jury did not find is in fact on the website as a part of our Board meeting agendas.

We will continue to improve the website in a thoughtful way to improve information accessibility to our stakeholders. This process with the Grand Jury to closely examine our website, along with feedback from other groups within our community, has led us to believe that there is a need for the District to consider replacing our current website with a more mobile- and user-friendly site that has updated content and navigation. By reviewing the organization and structure of the website, we will be making great strides in ensure that information is easily accessible.

Response: Agree


San Rafael City Schools is committed to transparency and believes in providing information with efficiency and integrity. We recognize the importance of maintaining accurate and consistent reporting and are cautious of creating a redundancy of work in regards to satisfying the request for compensation of elected officials, officers, and employees. Therefore, we have added on our District website information and a link to the state's Transparent California website (<http://transparentcalifornia.com>).

As also noted on our website, Board members in San Rafael City Schools are not compensated for their public service. Unlike other school district jurisdictions, elected trustees do not receive a monthly stipend or compensation for their term in office. The Board of Education views Board service as a voluntary contribution to the community and per city charter receives no compensation.

San Rafael City Schools

Across the state, district superintendents have been communicating with the State Controller's Office related to the Controller's request to provide compensation information on district staff. Payroll records for San Rafael City Schools are not maintained in a format suitable to comply with the Controller's request. It would create a significant burden and cost in the form of staff time to provide the information in the requested format, and we believe it is an unnecessary cost to the public.

Web Transparency Audit For School Districts

The audit is based on best practices for web transparency using ten (10) criteria (indicated by ). To indicate this website has a specific feature (e.g., "Mission Statement"), copy the website page's URL into the appropriate blank (e.g., "http://mywebsite.com/mission_statement.html"). If the website doesn't have a specific feature, leave the URL blank. A hard-to-find document is not considered "in the spirit of transparency" (i.e., non-searchable document or buried in board minutes).

Since there is no partial credit for scoring, ensure that you have ALL of the features for a criteria on your website.
