Please find the Tomales Village Community Services District (TVCSD) response to the Marin County Civil Grand Jury 2015-16 Web Transparency Report Card Report, dated March 10, 2016. There were three recommendation directed at TVCSD. Listed below are those recommendation and TVCSD's responses to them.

### **RECOMMENDATION 1:**

R1. The agency should improve its web transparency score to "B-" (or better), by updating its website and submitting the appropriate self-audit form. The form may be obtained by emailing: grandjury-audit@marincounty.org.

# Response:

We agree with this recommendation and are in the process of updating our website with the missing information. The web transparency checklist criteria numbers 10 separate criteria. Due to the part-time nature of the contract services that TVCSD uses to conduct its business, we anticipate completing many of these tasks by December 31, 2016. We are confident of earning at least a B- for TVCSD's web transparency report card. We will submit the self-audit form by January 15, 2017.

#### **RECOMMENDATION 2:**

R2. The agency should file and keep updated its Statement of Facts with the California Secretary of State and the Marin County Clerk as required by California Code §53051.
