Director Jones gave a brief update on where we are with the various remodel projects: CMA – which is final branch to be remodeled, will close after Thanksgiving and reopen on Tuesday, December 16. Total projected costs to complete major remodels since the passing of Measure in 2010 to the end date of June 30, 2015 will be \$2,649,014. Starting in 2015, we will have specific accounting measures for Measure A which will be separate from the general fund. Measure A generated 2.5 million per year, and a total of 12.5 million dollars over a 5 year period. After a brief question and answer period, President Schoen thanked Director Jones for her update.
