Pursuant to state and local guidelines implementing the California Environmental Quality Act, the Marin County Department of Public Works has prepared an initial study for the above-reference project. Prior to taking any action on the merits of the project, the Marin County Board of Supervisors will consider adoption of the Mitigated Negative Declaration of Environmental Impact for this project. Said public hearing will be held at the regular meeting of the Marin County Board of Supervisors on **Tuesday**, **February 10**, **2015**, in the Board of Supervisors Chambers (Suite 330 in the Administration Building), Marin Civic Center, San Rafael, California.
