## Voter's Choice Act in Marin

The Voter's Choice Act (VCA) is a law that allows counties to offer voters more choices for how, when, and where they vote. Under the VCA, all active registered voters are automatically mailed a ballot, early voting is expanded for more days, and voters may vote in-person at any regional vote center. Marin County first implemented the Voter's Choice Act during the June 7, 2022 primary election.

### How Does It Work?

All active registered voters are automatically mailed a ballot and have THREE ways to return it: (No stamp needed!)

- By mail
- At an official ballot drop box
- At a vote center

### What is a Vote Center?

Voters may vote in-person at ANY vote center in Marin County. Assigned, neighborhood polling places are replaced by regional vote centers that open at least 3 days before Election Day with MORE services:

- Register to vote & vote the same day
- Replace a lost or damaged ballot
- Early voting—vote before Election Day!
- Vote with an accessible voting machine
- Request help

## Vote Safe. Vote Secure. Vote by Mail.



It's easy! Voting by mail saves time, is safe, and is free! There are many ways to return a vote by mail ballot:

- ➊ VOTE your ballot; insert and seal it inside the mailing envelope that came with your ballot.
- ➋ SIGN the outside of the envelope; the ballot cannot be counted without your signature!
- ➌ RETURN your voted ballot by mail (to postmark on or before Election Day), OR take it to any Vote Center or Official Ballot Drop Box.

## Mark Your Calendar...

Sept. 29: Voter Information Guide mailing begins

Oct. 10: Vote by Mail Ballot mailing begins

Oct. 11: Ballot Drop Boxes open

Oct. 24: Deadline to register to vote

Oct. 29: Several vote centers open (through Nov. 8)

Nov. 5: ALL vote centers open (through Nov. 8)

Nov. 8: Election Day!  
Vote Centers close at 8 p.m.

Nov. 15: Deadline for officials to receive ballots by mail (had to be postmarked on or before Nov. 8)
