## NOTICE

If you forgot to sign your ballot return envelope, the Elections Department will send a letter with a postage-paid envelope so you may correct the problem. Or you may print and complete this form and return it as indicated in the instructions below.

### UNSIGNED BALLOT STATEMENT

I, \_\_\_\_\_, am a registered voter of Marin County, State of California. I declare under penalty of perjury that I requested and returned a vote by mail ballot and that I have not and will not vote more than one ballot in this election. I am a resident of the precinct in which I have voted, and I am the person whose name appears on the vote by mail ballot envelope. I understand that if I commit or attempt any fraud in connection with voting, or if I aid or abet fraud or attempt to aid or abet fraud in connection with voting, I may be convicted of a felony punishable by imprisonment for 16 months or two or three years. I understand that my failure to sign this statement means that my vote by mail ballot will be invalidated.

## RETURN INSTRUCTIONS

READ THESE INSTRUCTIONS CAREFULLY BEFORE COMPLETING THE STATEMENT. FAILURE TO FOLLOW THESE INSTRUCTIONS MAY CAUSE YOUR BALLOT NOT TO COUNT.

1. To ensure that your vote by mail ballot or provisional ballot will be counted, your statement should be completed and returned as soon as possible so that it can reach the elections official of the county in which your precinct is located no later than 5 p.m. two (2) days before the election is certified.
2. You must sign your name on the line above Voter's Signature.
3. Print the form and mail, deliver, or have delivered the completed statement to the Elections Department.
4. If you do not wish to send the statement by mail or have it delivered, you may submit your completed statement by facsimile or email transmission to your local elections official, or submit your completed statement (in an envelope addressed to the Elections Department) to a polling place within the county or a ballot drop-off box before the close of the polls on election day.
5. The signature provided on the complete Statement may be added to your registration record to be used for signature comparison purposes in future elections.
