COMMENDING
RANDY GREENBERG
ON THE OCCASION OF HER RETIREMENT
FROM THE MARIN COUNTY PLANNING COMMISSION

WHEREAS, Randy Greenberg was first appointed to the Marin County Planning Commission on April 27, 2004 by Supervisor Annette Rose, bringing with her a reputation as a no-nonsense, hard-working environmentalist and neighborhood activist from her prior years of service on the Tiburon Planning Commission and the Tiburon Parks and Open Space Commission; and

WHEREAS, Randy's contribution to the Commission was highly regarded and she was twice reappointed by the late Supervisor Charles McGlashan, first on June 28, 2005 and again for her last term on January 27, 2009; and

WHEREAS, Randy was conscientious about carrying out the duties and responsibilities of a Planning Commissioner, rarely missing a Planning Commission meeting, and always prepared; and

WHEREAS, Randy regularly went beyond the call of duty by conducting additional investigations on her own time and by attending neighborhood meetings to "get all of the facts" relevant to a particular land use item reviewed by the Planning Commission; and

WHEREAS, as the Chairman of the Marin County Planning Commission in 2008, Randy provided exemplary leadership, helping guide the Commission to reach consensus on a number of controversial projects, including preserving environmental values while allowing continued recreational uses at Lawson's Landing recreational campground; and

WHEREAS, during her tenure on the Commission, Randy provided invaluable insights and recommendations that helped shape a number of Commission decisions, including those on the Pt. Reyes Affordable Homes project and the Oakview Master Plans; and

WHEREAS, Randy was a steady and influential voice during the long Countywide Plan Update process, successfully advocating and supporting policies that increased protections for the County's baylands and, more recently, protection of Environmentally Sensitive Habitat Areas (ESHAs) as part of the Local Coastal Program Amendment process; and

WHEREAS, with quick wit, her characteristic laugh and a keen sense of timing and spot-on observation, Randy won the respect of her Commission colleagues and land use applicants alike by offering honest, straightforward guidance. Randy's devotion to doing the hard work - reading the fine print and studying the plans - over these many years has helped safeguard and protect Marin's natural and built environment.

NOW, THEREFORE, BE IT RESOLVED, that the Marin County Board of Supervisors hereby commends and thanks Randy Greenberg for providing exemplary public service, for her dedication to the highest ideals of environmental protection, and for her valuable guidance to the Marin County Planning Commission and to this Board in helping shape a better future for Marin County through wise land use policies and decisions.
