COMMENDING  
THE MARIN MEDICAL RESERVE CORPS VOLUNTEERS'  
RESPONSE DURING VALLEY FIRE

**WHEREAS**, the Marin Medical Reserve Corps (MMRC) is a volunteer program of the Marin County Department of Health and Human Services; and

**WHEREAS**, Marin County doctors, nurses, pharmacists, emergency medical technicians, and other non-medical volunteers support the MMRC with nearly 5,000 hours of volunteer work every year. These volunteers respond to public health and disaster medical needs in Marin County, and support the California State Emergency Management System as a Medical-Health resource; and

**WHEREAS**, the MMRC was called to support survivors of the Valley Fire and 39 MMRC volunteers did so during a nine day mission of medical and psychological care for Valley Fire survivors from September 21 – 29, 2015, in Middletown, California, traveling in teams from Marin to Lake County to staff first-aid treatment and emergency clinic sites; and

**WHEREAS**, the MMRC teams functioned with remarkable expertise in communications, logistics and clinical skills, administering to broken bones, wounds, urgent illness, and psychological needs with great care and professionalism during a stressful time in Lake County, as evacuated citizens returned to their fire-ravaged communities.
