SUBJECT: REQUEST TO APPROVE A LICENSE AGREEMENT WITH LAGUNITAS SCHOOL DISTRICT FOR MAINTENANCE OF THE SKATE PARK AT LAGUNITAS ELEMENTARY IN SAN GERONIMO VALLEY

Dear Board Members:

RECOMMENDATION: Approve the license and authorize the President to execute the same

SUMMARY: The Lagunitas School District (LSD) in partnership with the Valley Skate Club (VSC) wish to develop a skate park at the site of Lagunitas Elementary School. The VSC was formed by a group of 8th grade students with a mission of facilitating the construction, maintenance, and expansion of a skate park in the San Geronimo Valley. The partnership between LSD and VSC is in direct support of the VSC mission.

Upon entering into a partnership with the VSC, the LSD requested that Marin County Parks (MCP) assist the VSC and LSD with management and non-routine maintenance of the future skate park. By assisting in the maintenance and management of the future skate park, MCP will contribute to its mission of providing access to public recreation countywide. By fulfilling this request and entering into the license agreement before your Board, MCP will help to add a recreational facility in the unincorporated area of West Marin, which is currently lacking in active, public recreation opportunities.

EQUITY STATEMENT: As noted above, this purpose of this agreement is to facilitate the construction of a skate park in West Marin, which is currently lacking in recreational opportunities for its youth. By agreeing to the terms specified herein, the County will enable the expansion of recreational opportunities for the currently underserved youth of West Marin.

FISCAL IMPACT: Approval will not increase General Fund net county cost. Staff anticipates that minimal time and material expenses will be needed to support this agreement and those will be incorporated into the departments' existing baseline expenditure appropriations.
