**Notice of Public Meetings for the 2024-25 Funding Cycle:
Discussion and Allocation of Funds to Affordable Housing, Community
Infrastructure, and Public Services Projects**

NOTICE IS HEREBY GIVEN that there are five (5) upcoming meetings regarding multiple federal, state, and local funding sources for housing, community infrastructure, and public services projects in Marin County. These funding sources are:

- Federal Community Development Block Grant (CDBG)
- Federal HOME Investment Partnerships Program (HOME)
- State Permanent Local Housing Allocation (PLHA) matched by the local Marin County Affordable Housing Fund (HTF)

Between January 22 and February 16, 2024, the County opened the 2024-25 funding cycle for the sources listed above and received 35 applications. These applications will be discussed and voted on at the upcoming Countywide Priority Setting Committee meetings, Novato City Council meeting, and San Rafael City Council meeting. After these meetings, recommendations will then be presented to the Marin County Board of Supervisors for final approval.
