REGULAR MEETING OF THE MARIN COUNTY BOARD OF SUPERVISORS HELD TUESDAY, JANUARY 10, 2006, AT 10:34 A.M.

The Board convened as the Marin County Housing Authority Board of Commissioners at 9:05 a.m., as the Marin County Transit District Board of Directors at 9:16 a.m., and as the Board of Supervisors at 10:34 a.m. All Supervisors were present.

The Board took a brief recess at 10:35 a.m. and reconvened at 10:44 a.m. All Supervisors were present.

3. ORGANIZATION OF THE BOARD

5. STATUS REPORT REGARDING RECENT STORM DAMAGE

County Administrator Matthew Hymel acknowledged County staff for their excellent response last week during the New Year's Eve storm and announced that the Federal Emergency Management Agency ("FEMA") National Flood Insurance Program review is complete.

Supervisor Murray, speaking as the Marin County Director of Emergency Services, expressed concern regarding the storm damage and thanked all County staff for their heroic efforts during the storm. Supervisor Murray gave a brief synopsis of the storm damage and cleanup, requested staff to initiate a process to establish a Marin County storm relief fund, and encouraged staff to promote a cleanup that is environmentally friendly.

Fire Chief Massucco acknowledged County Fire Department staff, briefly reported on the Fire Department's response during the New Year's Eve storm, and noted the extensive collaboration among the Fire Department, Office of Emergency Services ("OES"), Sheriff's Department, Department of Public Works, and the Urban Search and Rescue ("USAR") team.

Public Works Director Farhad Mansourian acknowledged the USAR team including Marin County Department of Public Works, Marin County Fire Department, Marin County Sheriff's Department, Novato Fire Protection District, Kentfield Fire Protection District, U.S. National Parks Service, Mill Valley Fire Department, Southern Marin Fire Department, Larkspur Fire Department, Cooper Crane and Rigging, Republic Electric, Marin General Hospital, Tiburon Fire Protection District, Ross Valley Fire Department, Ross Valley Fire Protection District, Inverness Volunteer Fire Department, Golden Gate National Recreation Fire Department, and Presidio Fire Department.

Mr. Mansourian stated that the County can be very proud of its response efforts and gave a brief Power Point slide presentation updating the Board on storm damage and cleanup. Mr. Mansourian reported on the status of storm damage repairs to Marin County hillsides, Marin businesses, Novato Creek and Pacheco Creek Levees, and several County roadways.

Chief Massucco provided the Board with a copy of the Pre-Flood Incident Action Plan and briefly commented on how this document prepared staff for the New Year's Eve storm.

Mr. Mansourian and Chief Massucco concluded by thanking the Board for its commitment to the safety of Marin County residents and for funding the USAR Team.

Sheriff Bob Doyle updated the Board on communications during the height of the New Year's Eve storm and stated that the calls more than tripled.

A Lucas Valley Homeowner's Association representative thanked Mr. Mansourian and Public Work staff for their speed, efficiency, and sensitivity to the residents. Several members of the public addressed the Board regarding several issues including new construction and flood control, Lagunitas Creek cleanup, and Corte Madera Creek improvements.

Board members and staff discussed the Telephone Emergency Notification System ("TENS") and the Marin Emergency Automated Notification System ("MEANS"). Supervisor Brown requested the TENS and MEANS to be activated County-wide as soon as possible.

Board members individually thanked all County staff and volunteers and briefly commented on the assistance of the Marin Emergency Radio Authority ("MERA") system, Marin County Community Emergency Response Training ("CERT") program, and Disaster Area Response Teams ("DART").

By letter dated January 10, 2006, County Administrator Matthew Hymel submitted his report and recommendations, on behalf of Supervisors Murray and Adams, regarding the above-captioned matter.

M/s Supervisor Murray - Supervisor Kinsey to

- a. adopt Resolution No. 2006-05 reconfirming the need to continue the local emergency for the County established by Emergency Proclamation of the Assistant Director of Emergency Services on December 31, 2005, and ratified by the Board of Supervisors Resolution No. 2006-01 adopted on January 6, 2006; and
- b. delegate appropriation authority to the Auditor to establish and transfer necessary funds to cover emergency response expenditures related to the winter storms, subject to County Administrator approval.

In response to a question from Supervisor McGlashan, County Administrator Matthew Hymel explained that this action will allow the Auditor to set up a budget center specifically for winter storm expenses to track for Federal Emergency Management Agency ("FEMA") reimbursement, should that become available.

Remarks by Supervisors

Supervisor Kinsey acknowledged the Assistant Clerk of the Board of Supervisors Diane Patterson and staff for their efforts in support of the Board, his aides Lisa Crosse and David Escobar, the other members of the Board and all County staff for their service to the community. Supervisor Kinsey advised that he is looking forward this year to the completion of the Marin Emergency Radio system and Marin County's Countywide Plan update. Supervisor Kinsey stated that he is committed to completing a financing plan for a sustainable health insurance program for all children and to long-term expansion of the County's wildland fire management programs. Supervisor Kinsey spoke about the importance of addressing transportation issues, shared his New Year's resolution to reduce his single-occupancy vehicle use by utilizing alternative transportation to work, and expressed the hope that Marin's residents would take similar measures to reduce traffic congestion.

Supervisor Murray echoed Supervisor Kinsey's remarks and noted that other important issues this year include the Community Choice Aggregation program, transit-oriented affordable

housing, senior needs assessment, improving emergency services, moving forward with the Marin Center Renaissance Project, participating in the Integrated Regional Water Management Planning project, and working to continue to be an employer of choice.

Supervisor Adams acknowledged her aides Rick Fraites and Ron Ford, expressed pride in the Marin community for their support of each other during the recent winter storms, and acknowledged County staff for their extraordinary response during a difficult time. Supervisor Adams noted that additional issues of importance this year include the health of the County's residents, environment and economy, development of a watershed plan, completion of the tenyear plan to end homelessness, continued public meetings and input regarding San Rafael Rock Quarry issues, and support for agriculture, multi-modal transportation, and affordable housing. Supervisor Adams noted that future challenges include, in the light of recent flooding, reducing the amount of impervious surfaces in future building, improving communication with Marin's cities and towns, remaining active with the County's state and federal legislators, and encouraging continued public participation in local government.

Paradise Cay Yacht Harbor

Two neighbors of the Paradise Cay Marina in Tiburon spoke regarding the poor condition of the yacht harbor and called for a show of hands of those present for this issue, with approximately thirty people raising their hands. One of the speakers presented a petition signed by sixty-three Paradise Cay residents regarding enforcement of the Marina use permits and requested that neighborhood representatives be included in discussions regarding the proposed stipulated agreement.

Supervisor McGlashan commented that efforts are being made, both at the Bay Conservation and Development Commission ("BCDC") and at the County, to reach a fair resolution to the matter. Supervisor McGlashan added that a BCDC representative will be meeting with community members to discuss the concepts in the potential stipulated agreement.

Global Concerns

Several members of the public addressed the Board regarding opposition to the war in Iraq and adoption of a resolution to repeal Public Law 107-243, Authorization for Use of Military Force Against Iraq Resolution of 2002.

Novato Creek Dredging

A member of the public expressed concern regarding health impacts which she stated came from dredged materials from Novato Creek.
