Mr. Schorske presented the 2005 Jobs Summit Report and briefly summarized the deliberations at the Summit and the subsequent work of the WIB to advance four "key recommendations" arising from the Summit as follows: to focus workforce and economic development on a small number of higher-wage industry clusters; to increase public and private investment in workforce and economic development; to develop a robust economic development capability in the County; and to help develop exemplary school-to-career pathways in targeted industries. Mr. Schorske reported that the 2006 Marin Workforce Action Plan will be released at the next Summit on Thursday, March 30, 2006. Mr. Schorske concluded his report by thanking Board members for sponsoring the WIB.

Board members thanked WIB members, discussed several issues including Project Hablamos, tracking the loss of jobs, affordable workforce housing, and encouraged WIB to work closely with the Marin Employment Connection ("MEC").

15. REQUEST FROM THE HEALTH AND HUMAN SERVICES DEPARTMENT TO ADOPT A RESOLUTION APPROVING THE MARIN COUNTY COMMUNITY SERVICES AND SUPPORTS PLAN FOR THE MENTAL HEALTH SERVICES ACT (PROPOSITION 63)

By letter dated January 31, 2006, Health and Human Services Director Dr. Larry Meredith submitted his report and recommendations regarding the above-captioned matter.

Community Mental Health Services Director Bruce Gurganus acknowledged staff, the Mental Health Board and the Steering Committee for their efforts during this process and briefly summarized the Marin County Community Services and Supports Plan ("Plan").

Mr. Gurganus responded to questions from Board members regarding the public's ability to comment on the Plan, comments by Service Employees International Union ("SEIU") representatives, funding discrepancies among counties, and the proposed new multipurpose facility.

A representative of the Marin Network of Mental Health Clients expressed agreement with the proposed Plan but requested that there be a transition period to keep the Enterprise Resource Center in downtown San Rafael open while the new Wellness Center in the Canal area is being launched.

Several representatives of the Marin Network of Mental Health Clients and members of the public urged the Board to keep the Enterprise Resource Center open, citing its proximity to downtown San Rafael and to transportation. The speakers also expressed concern regarding transportation and safety issues for the proposed location of the new facility.

The Executive Director of the Canal Alliance spoke in favor of locating a mental health services facility in the Canal area of San Rafael, citing the need for these services.

The written comments of a member of the public supporting the Plan, especially as it relates to older adults, were submitted.

Board members thanked the members of the public who spoke on this issue. Board members also commented on the Support and Treatment After Release ("STAR") Program and the Mental Health Court, the possibility of keeping both the old and new facilities open, and the importance of establishing a transition program from the old to the new facility if keeping them both is not possible.

16. SUPERVISOR KINSEY REQUESTING A REPORT ON THE STATE OF AGRICULTURE IN MARIN COUNTY

By memorandum dated January 31, 2006, Supervisor Kinsey submitted his report, acknowledged the work of his aide Liza Crosse, and spoke about some of the key issues currently facing the agricultural industry.

Agricultural Commissioner Stacy Carlsen, Farm Advisor Ellie Rilla and Agricultural Consultant Lisa Bush presented information regarding Marin's agricultural industry, as well as some recommendations to support its continuing viability.

The Executive Director of Marin Organic, the Executive Director of the Marin County Farmers Market Association, the Associate Director and a member of the Board of Directors of the Marin Agricultural Land Trust ("MALT"), and several members of the public spoke about the value of the actions taken by the Board to promote agriculture in Marin. Some of the speakers also expressed concerns about water availability and loss of infrastructure for Marin's agriculture industry.

Board members expressed their continued commitment to support Marin's agricultural and requested staff to return to the Board with a Work Plan to address areas of concern.

The Board recessed at 1:10 p.m. to meet in closed session.

18. WORKSHOP: REVIEW OF A FEASIBILITY STUDY FOR THE DEVELOPMENT OF A PUBLIC SAFETY/EMERGENCY OPERATIONS BUILDING

By letter dated January 31, 2006, Facilities Planning and Development Manager David Speer submitted his report regarding the above-captioned matter. Mr. Speer acknowledged Administrative Analyst Lisa De Carlo for her efforts to coordinate this project and presented a brief overview of the background and context for the feasibility study.

Consultant Beverly Prior briefly presented a summary of findings from the feasibility study.

Several members of the public expressed concerns regarding noise and safety issues, lighting and traffic impacts, and the potential dislocation of the petanque court and temporary dog park, and urged the Board to consider alternative sites.

Board members commented on optional sites for the safety building, alternative sites for the petanque court and dog park, the proposed facility exit on Golf Avenue, and potential impacts to the community.

Board members directed staff to look into the issues raised today, develop a project timeline for the development process, and report back to the Board.

The meeting was adjourned at 3:06 p.m. in memory of Roger Grossman.
